The ornamental design for a bicycle frame, as shown and described.

DESCRIPTION

FIG. 1 is a right side view of a bicycle frame according to my novel design;

FIG. 2 is a left side view of a bicycle frame according to my novel design;

FIG. 3 is a front view of a bicycle frame according to my novel design;

FIG. 4 is a rear view of a bicycle frame according to my novel design;

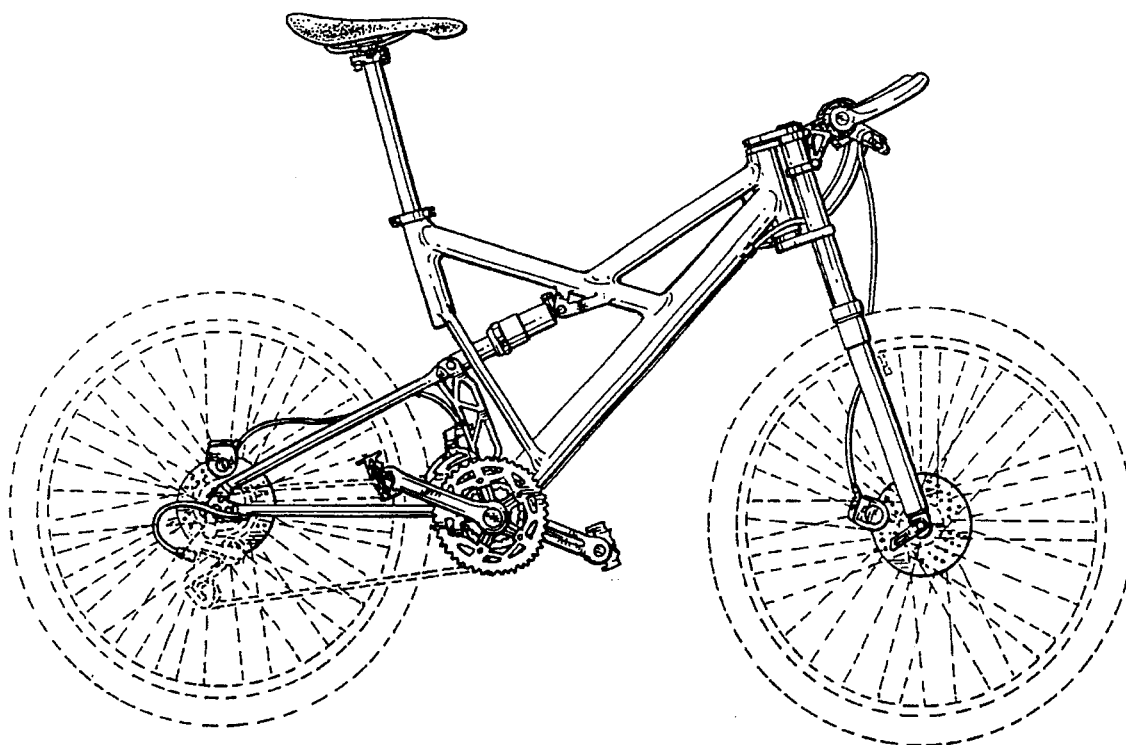
FIG. 5 is a perspective view from above and the right side of the bicycle frame according to my novel design;

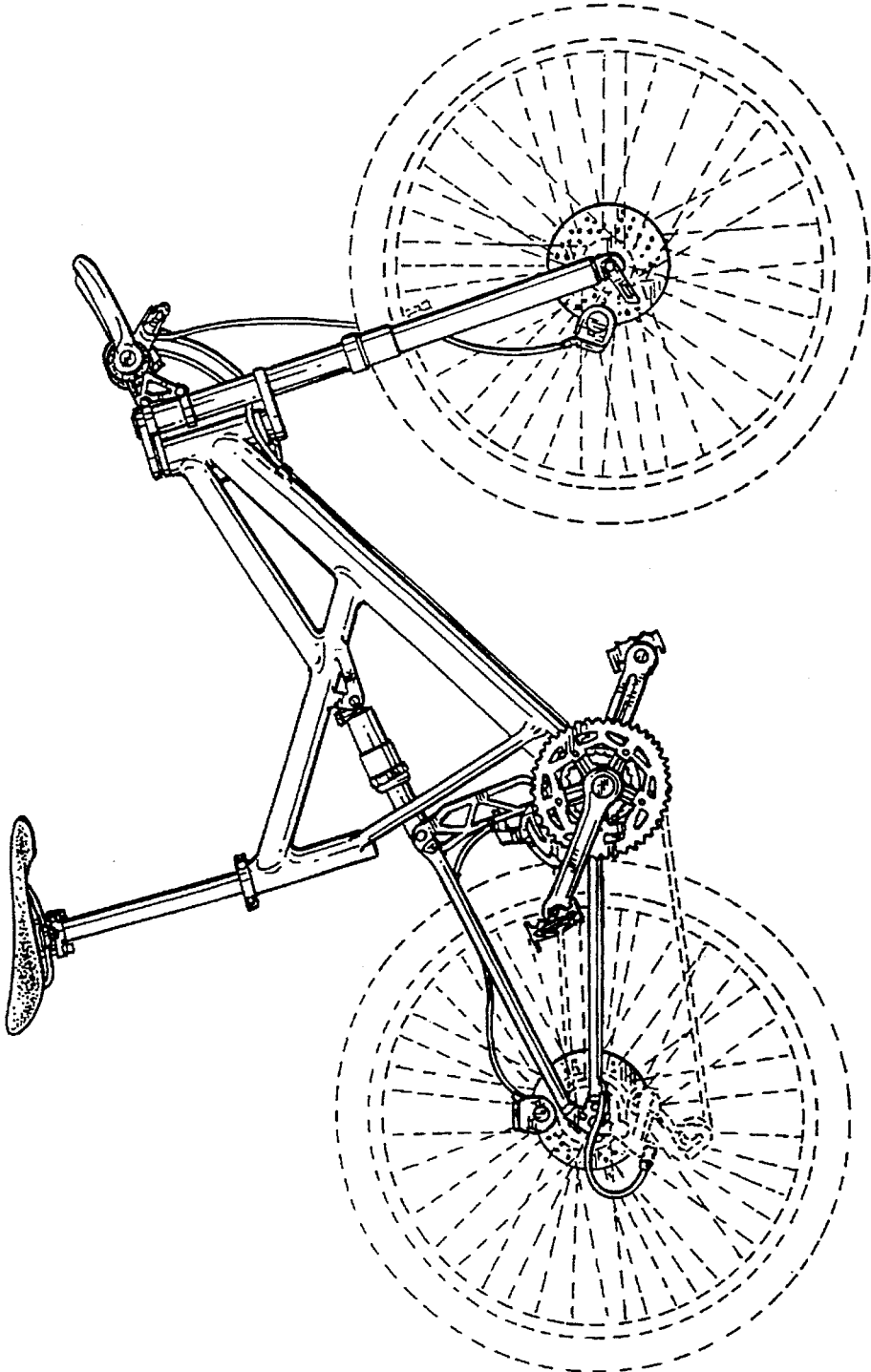

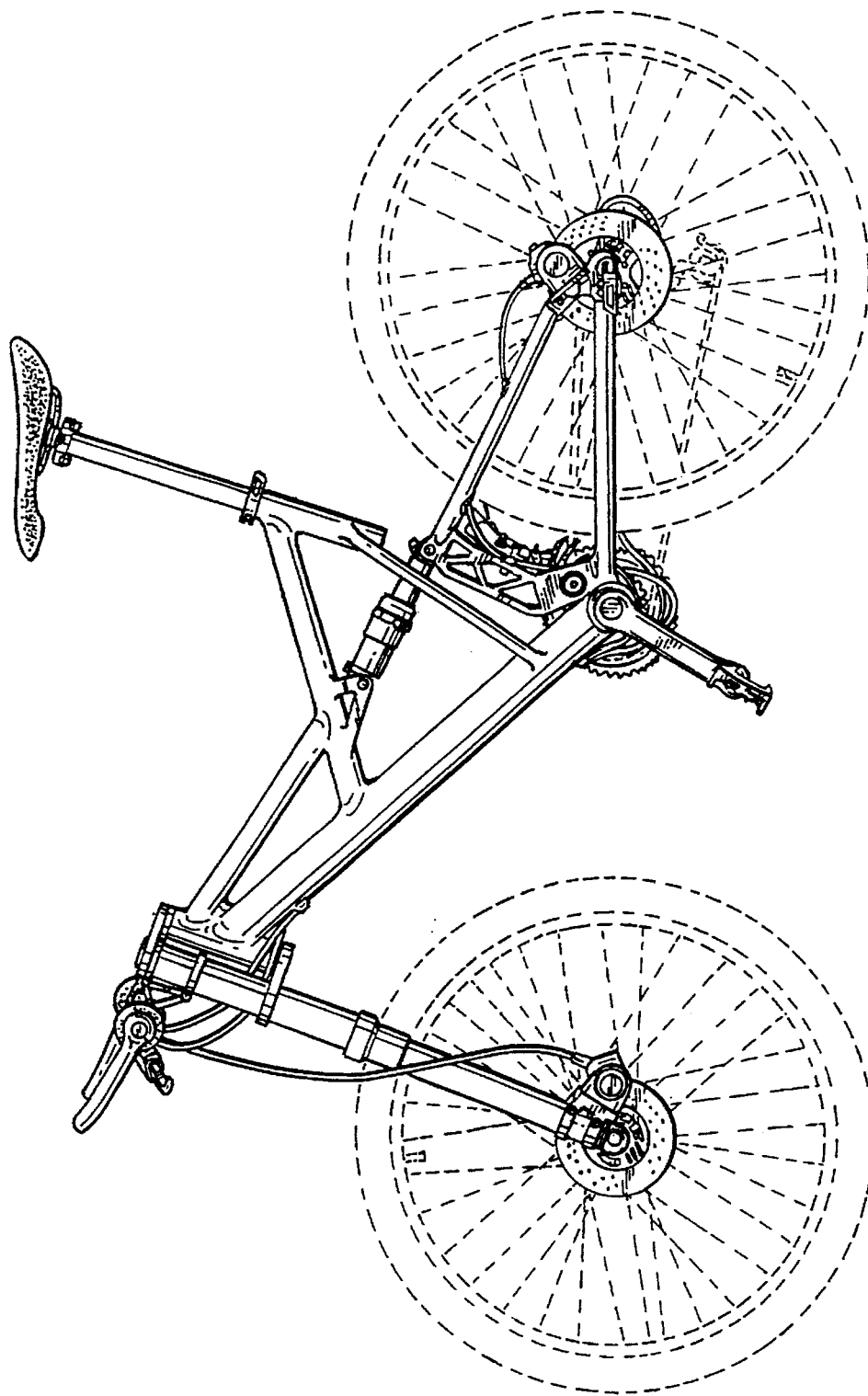

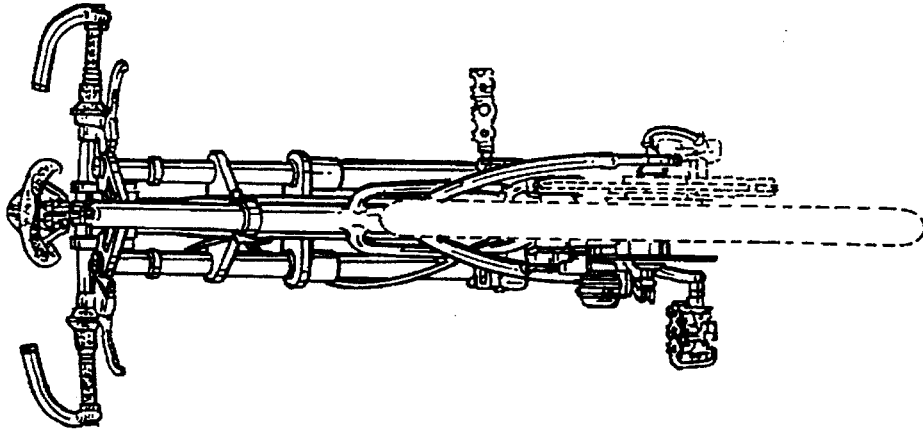

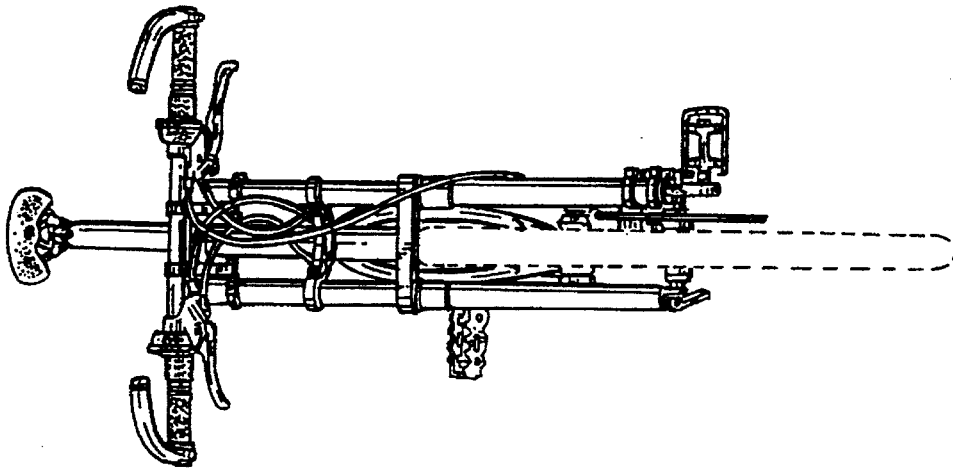

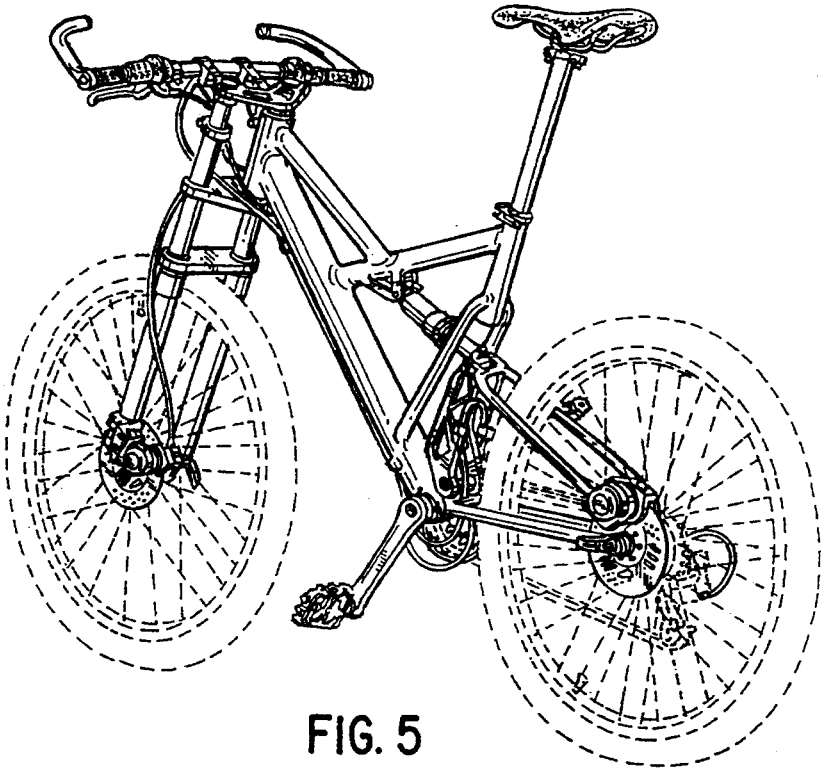

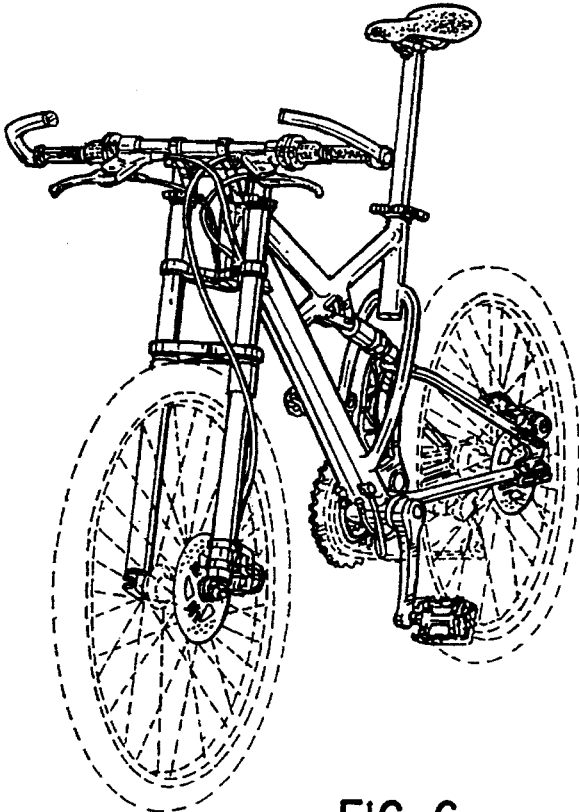

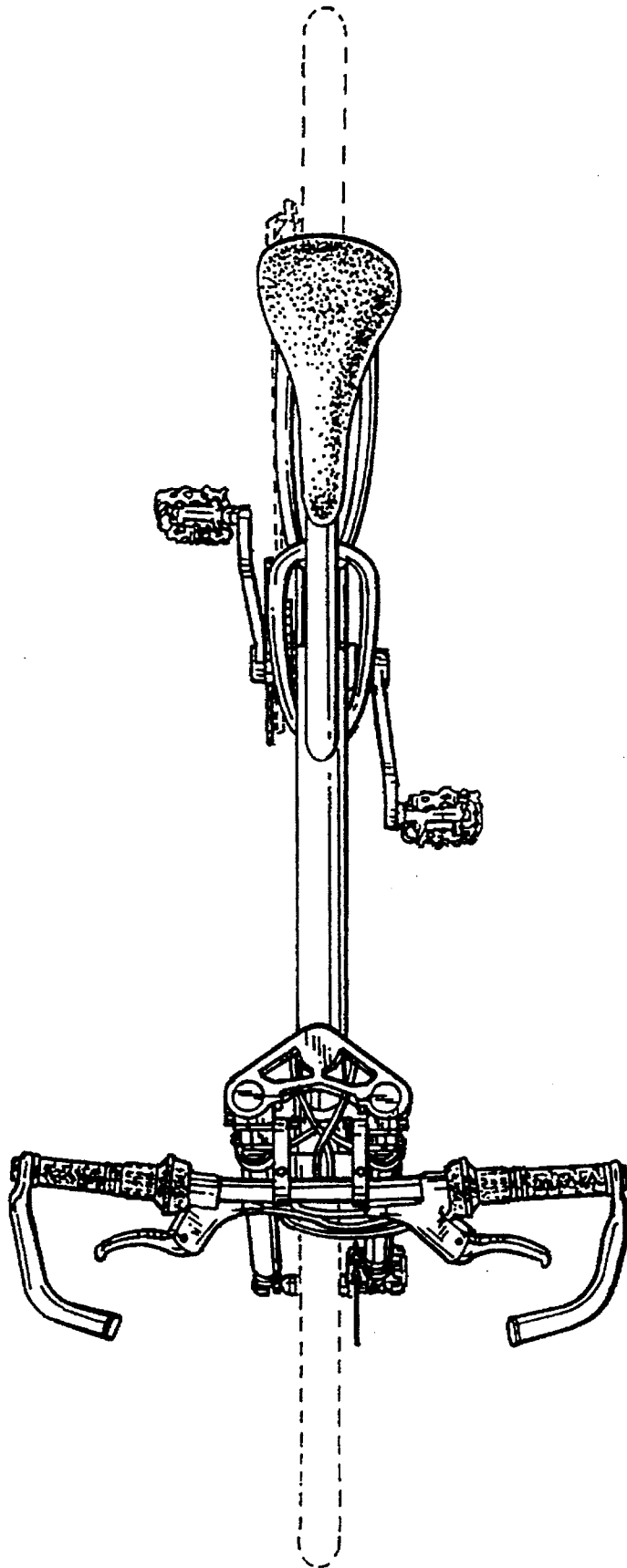
