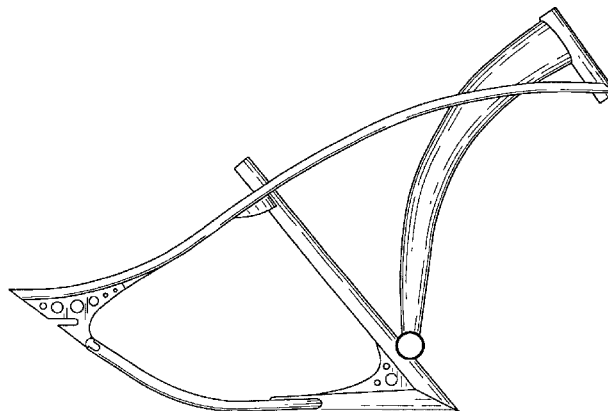
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a top plan view of a men's bicycle frame of the present invention showing our new design;  
FIG. 2 is rear elevational view thereof;  
FIG. 3 is side elevational view thereof;  
FIG. 4 is front end view thereof;  
FIG. 5 is a bottom plan view thereof; and,  
FIG. 6 is a side elevational view thereof with the broken lines depicting solely environmental structure and forming no part of the claimed design.

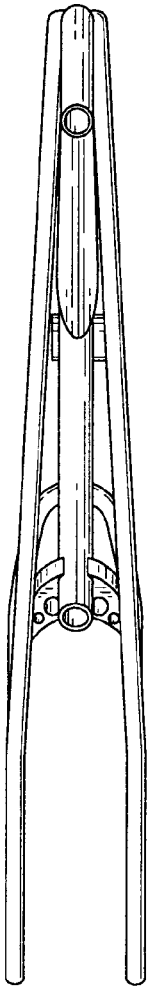

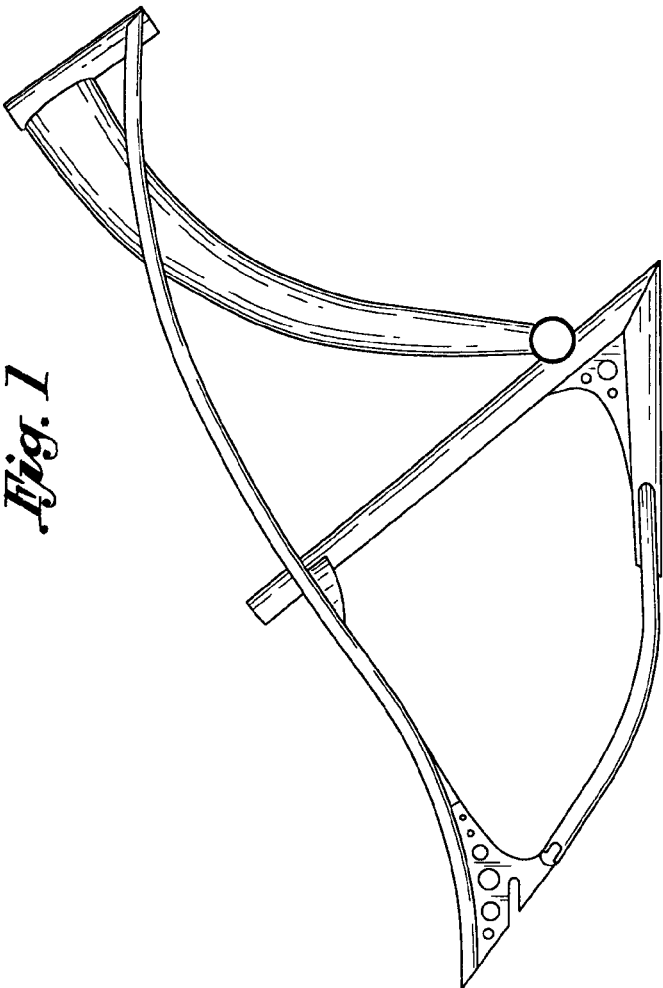

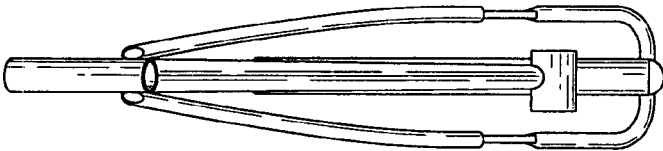

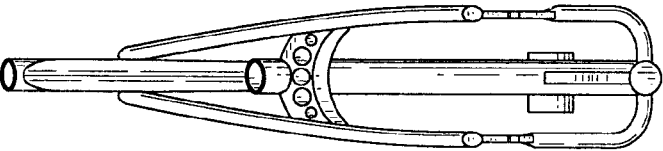

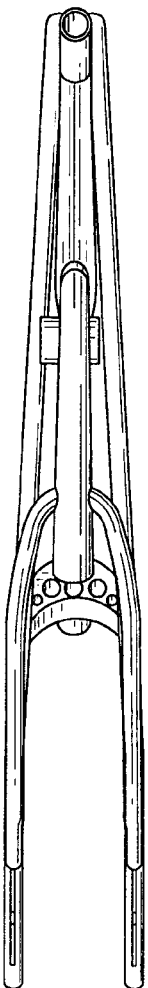

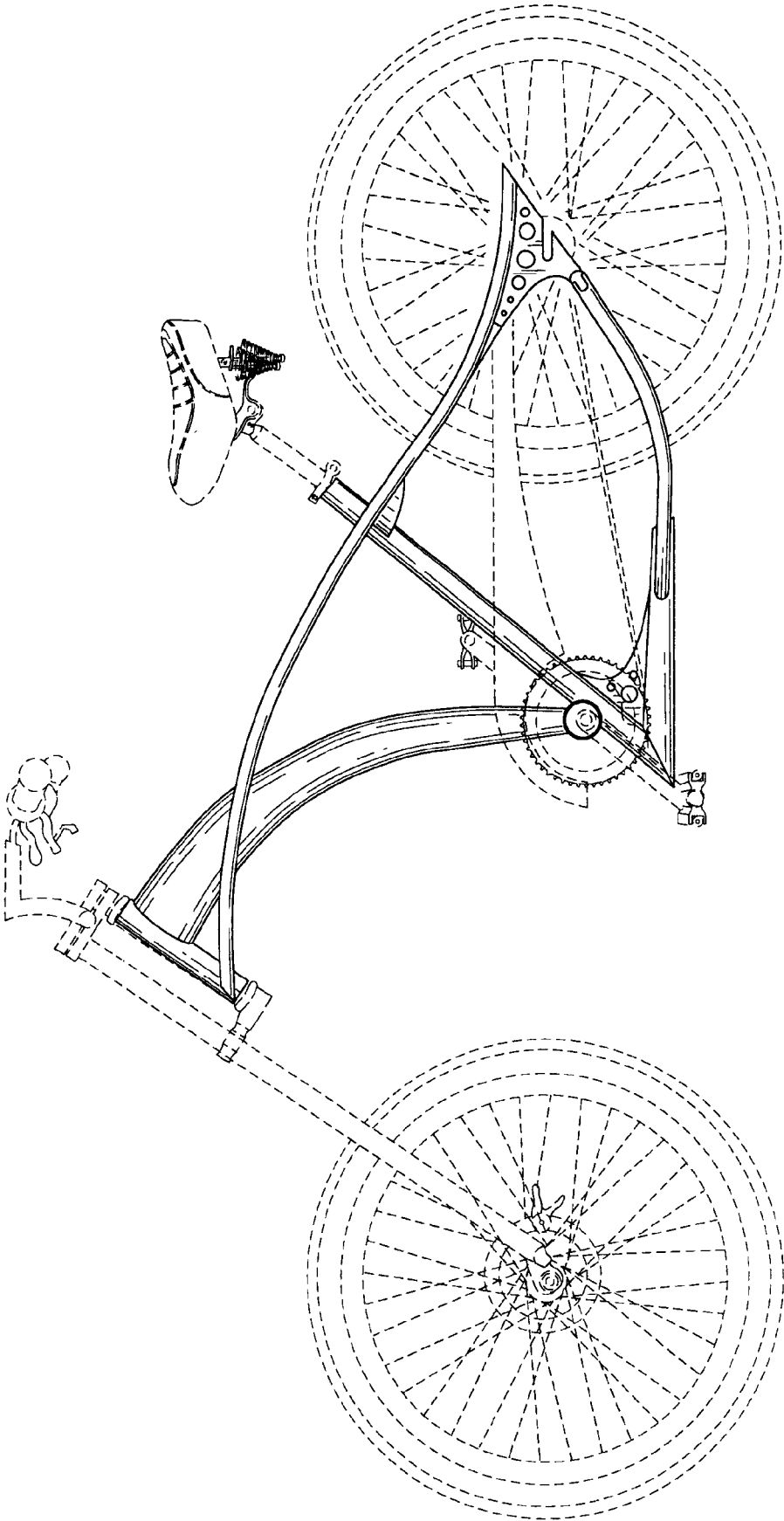
