FIG. 3 is a rear plan view thereof;

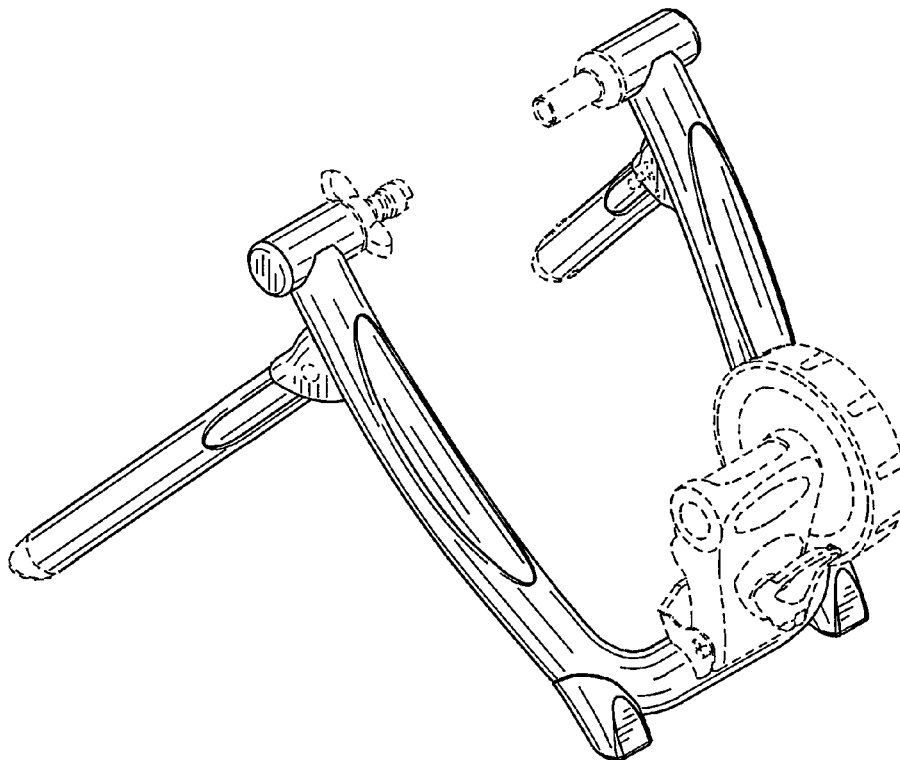
FIG. 4 is a right side elevation view thereof;

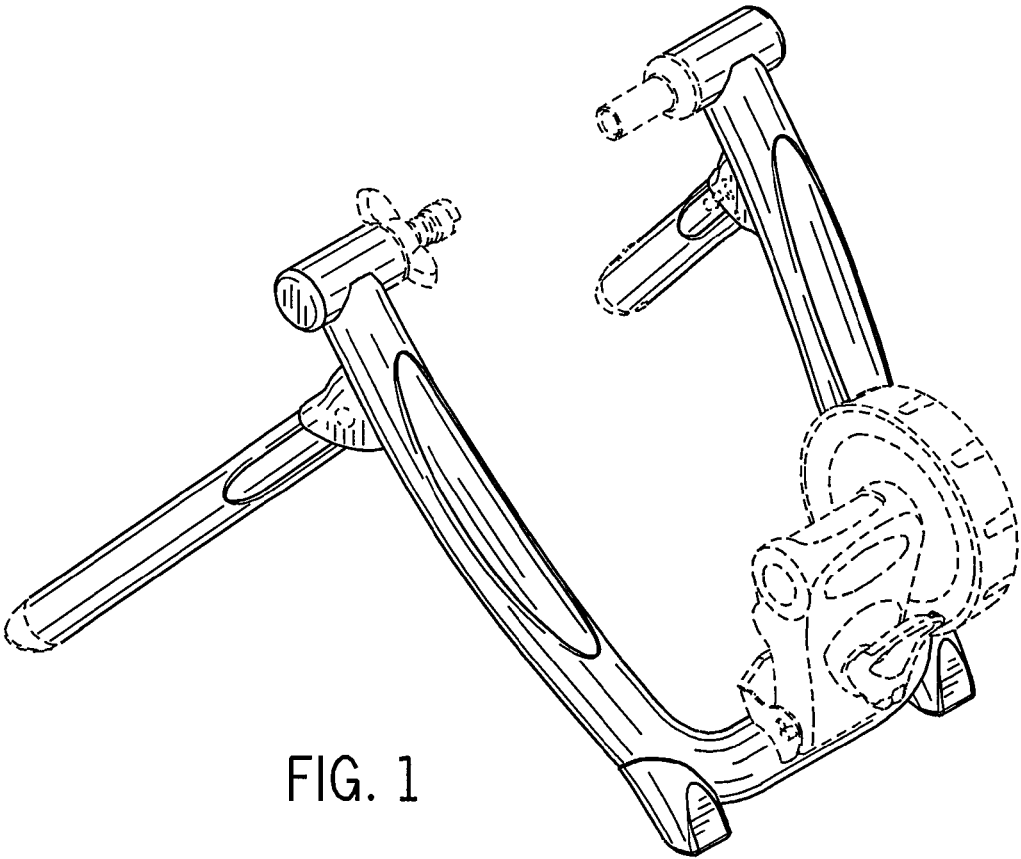

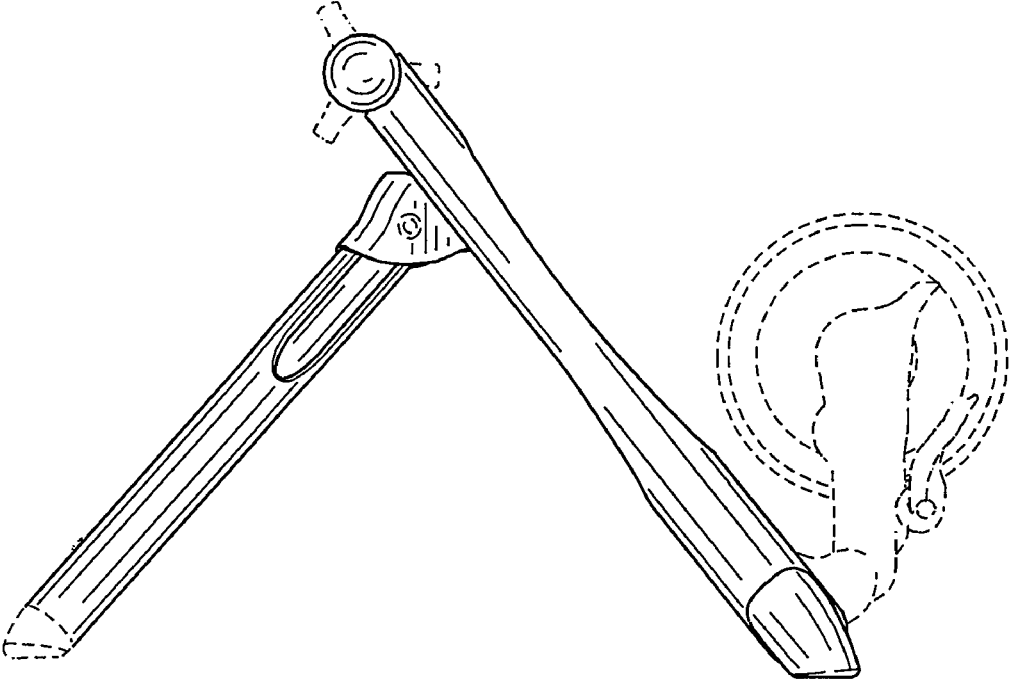

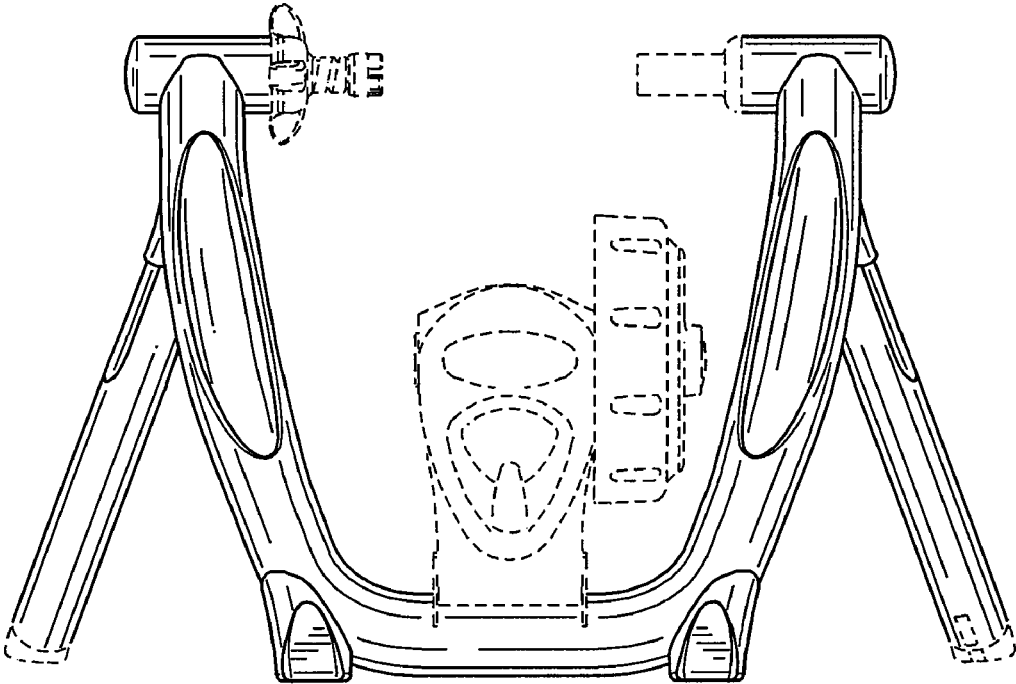

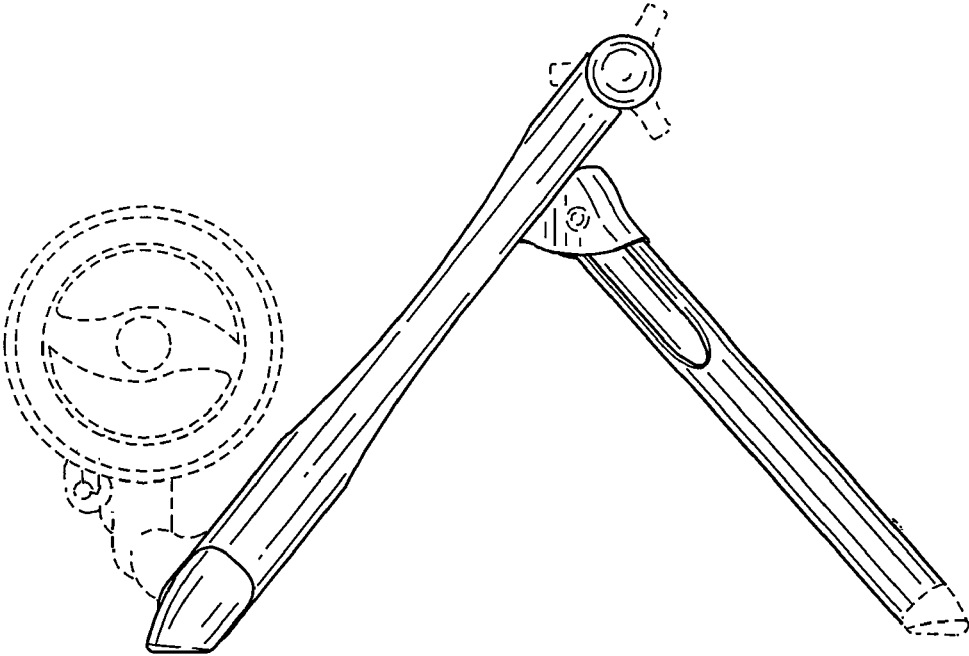

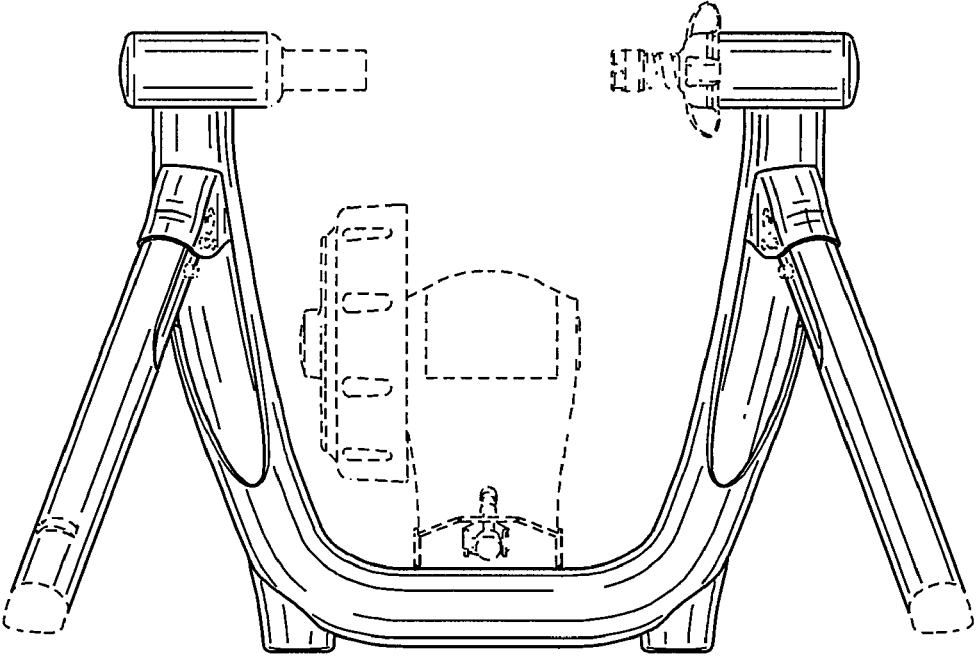

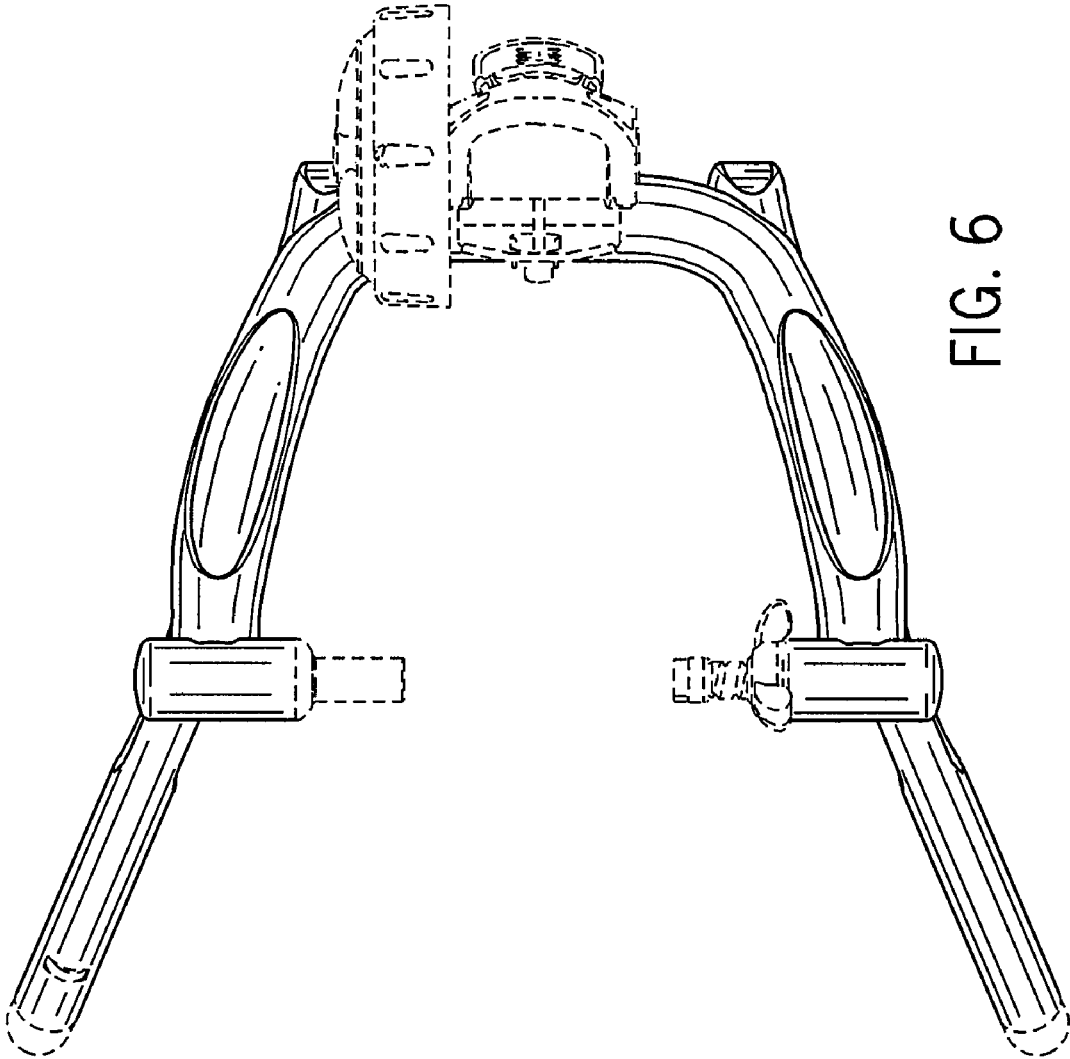

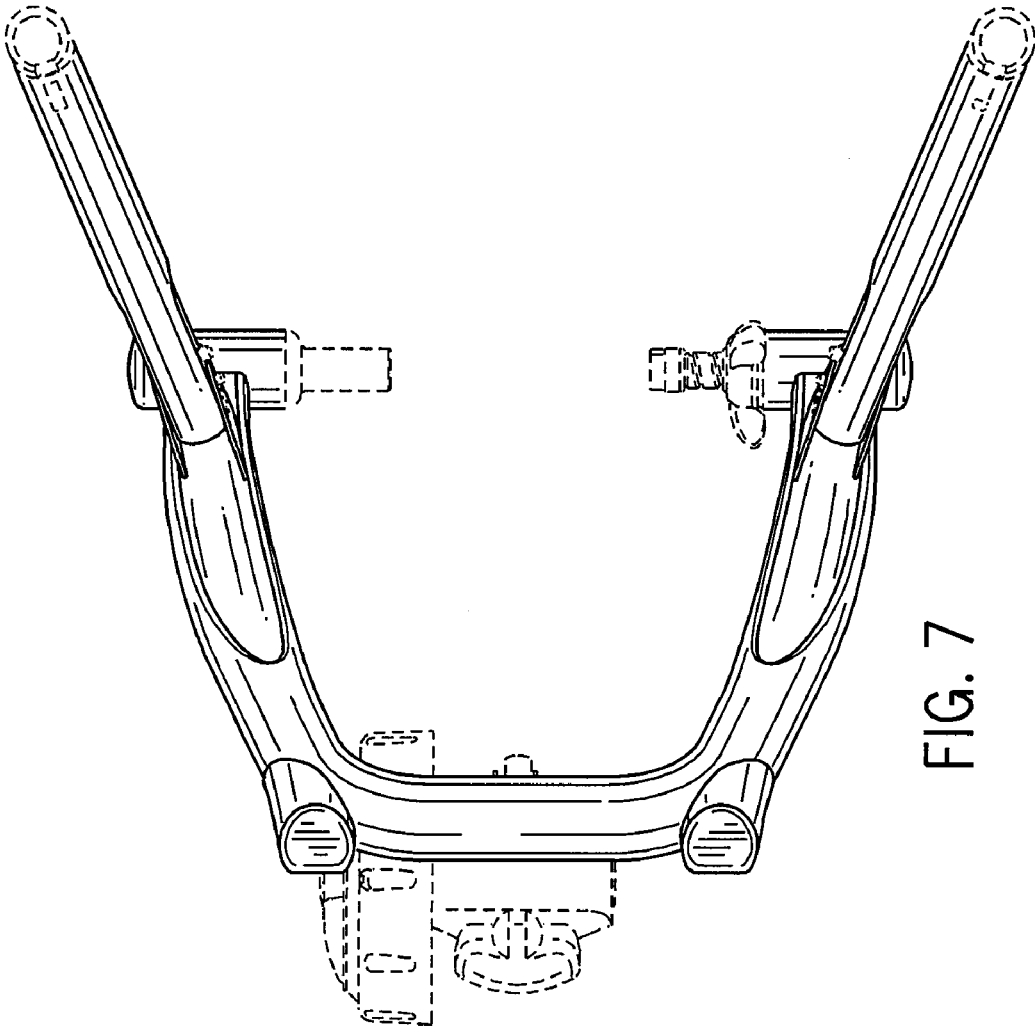
