FIG. 5 is a bottom view of the bicycle frame storage case.

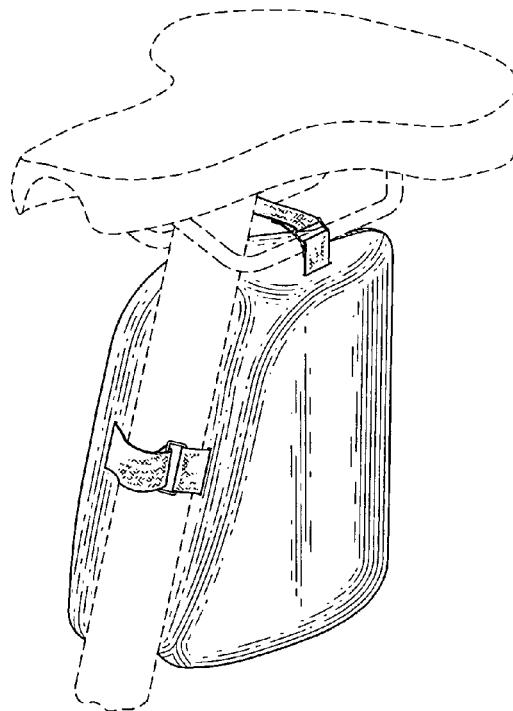
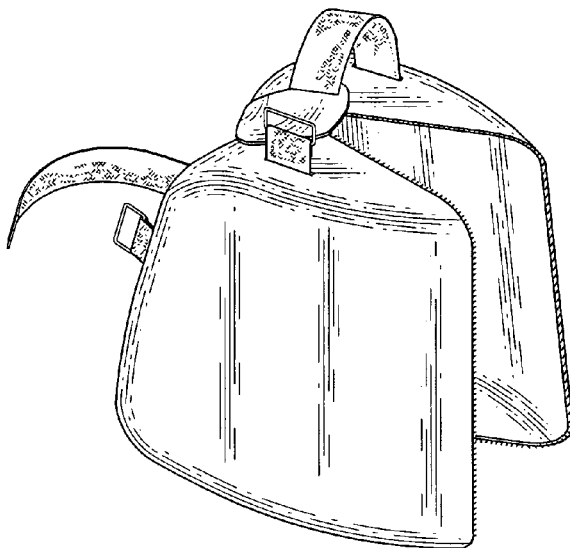
FIG. 6 is a right side view of the bicycle frame storage case.

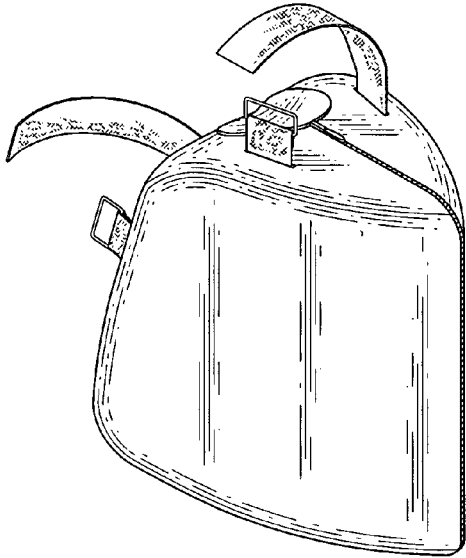

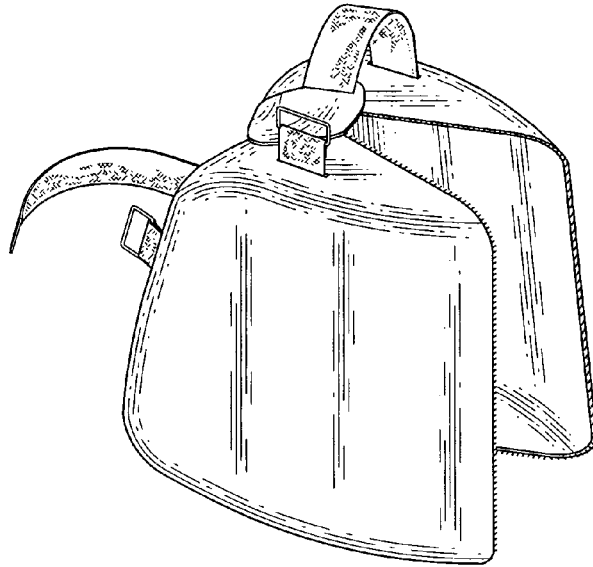

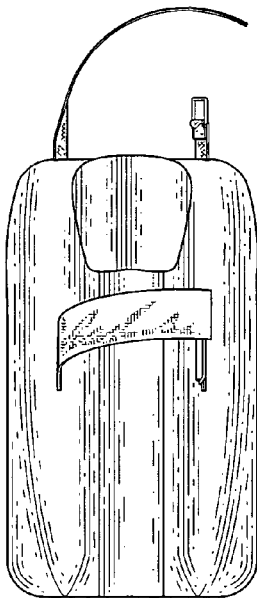

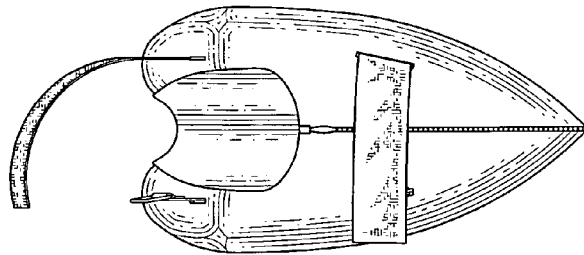

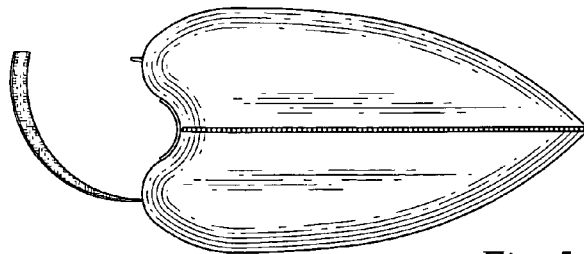

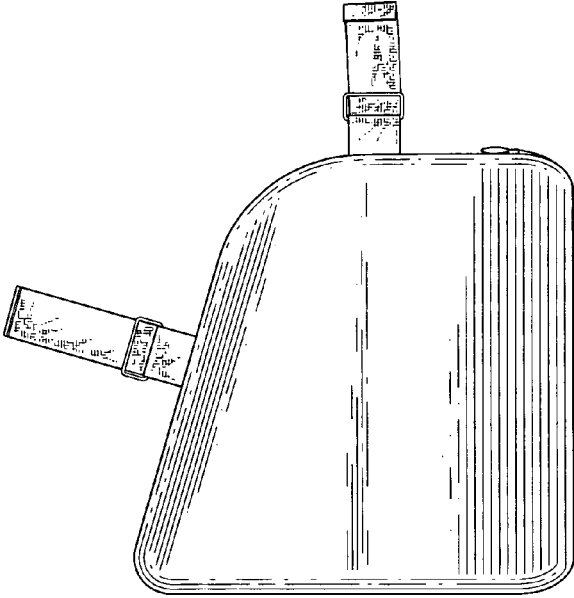

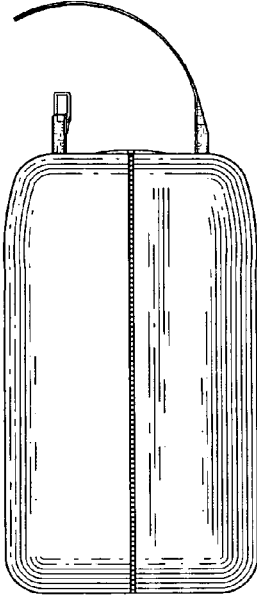

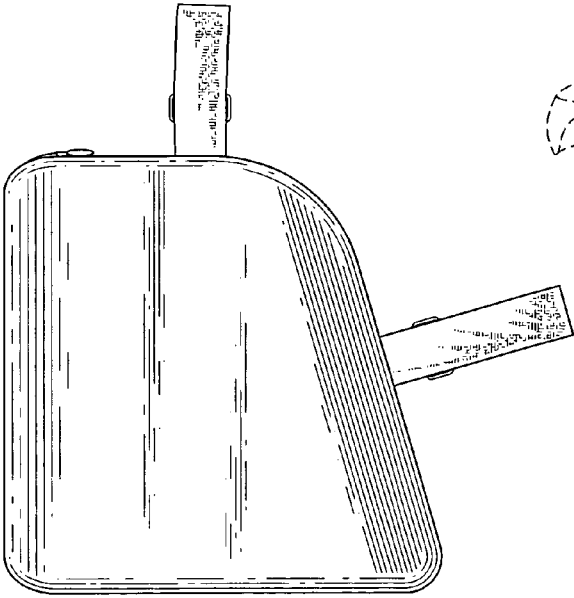

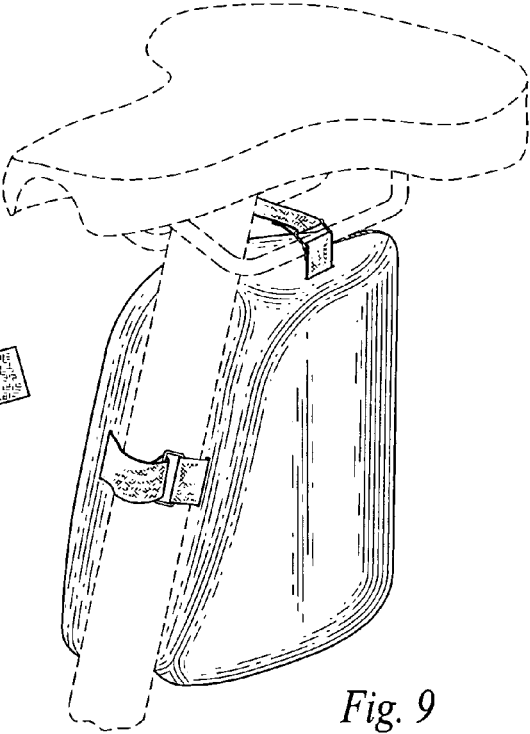
