DESCRIPTION

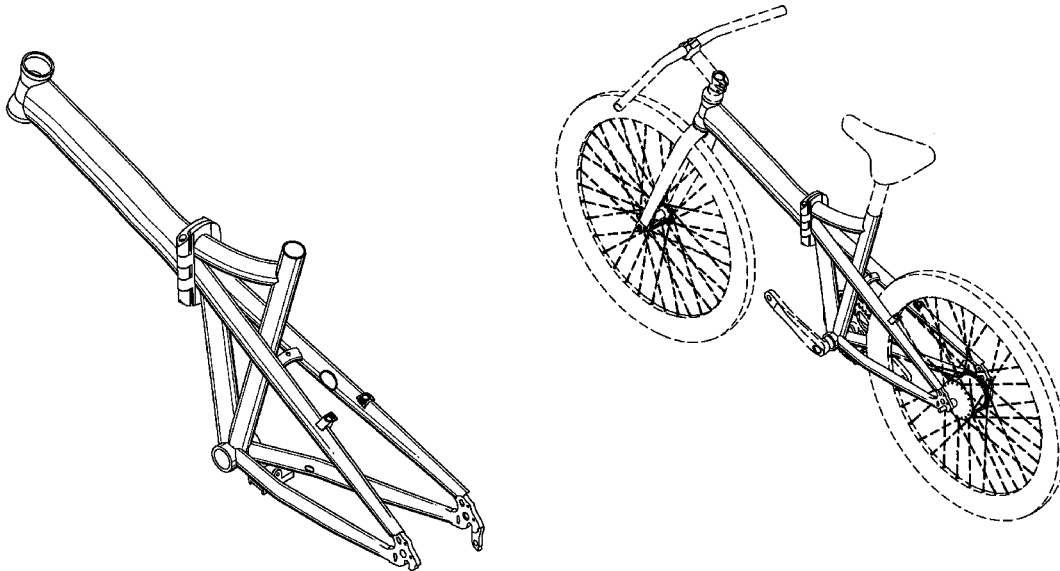
FIG. 1 is a perspective view of a foldable bicycle frame showing my new design;

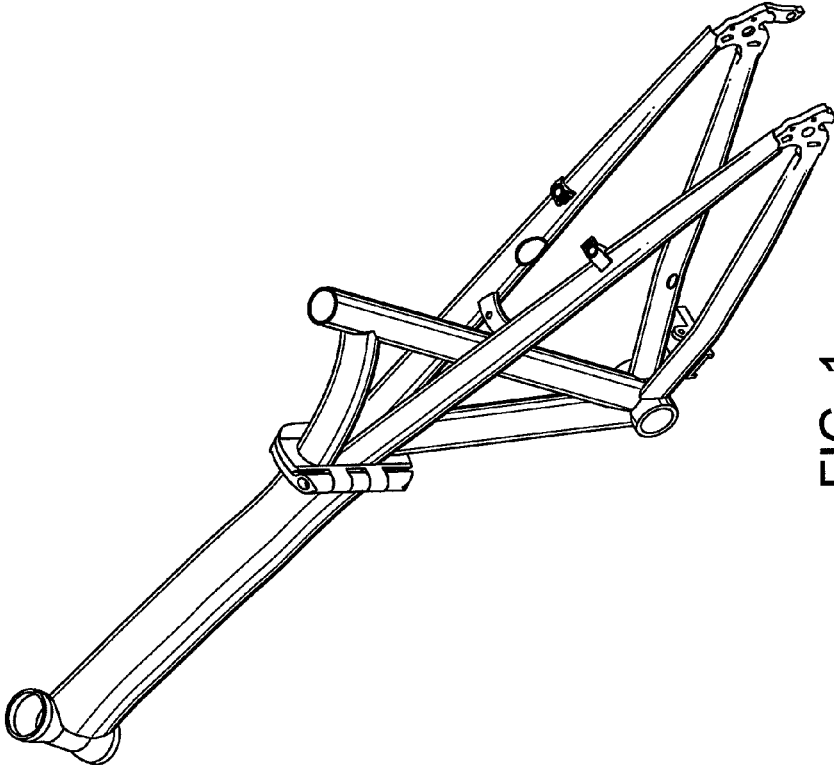

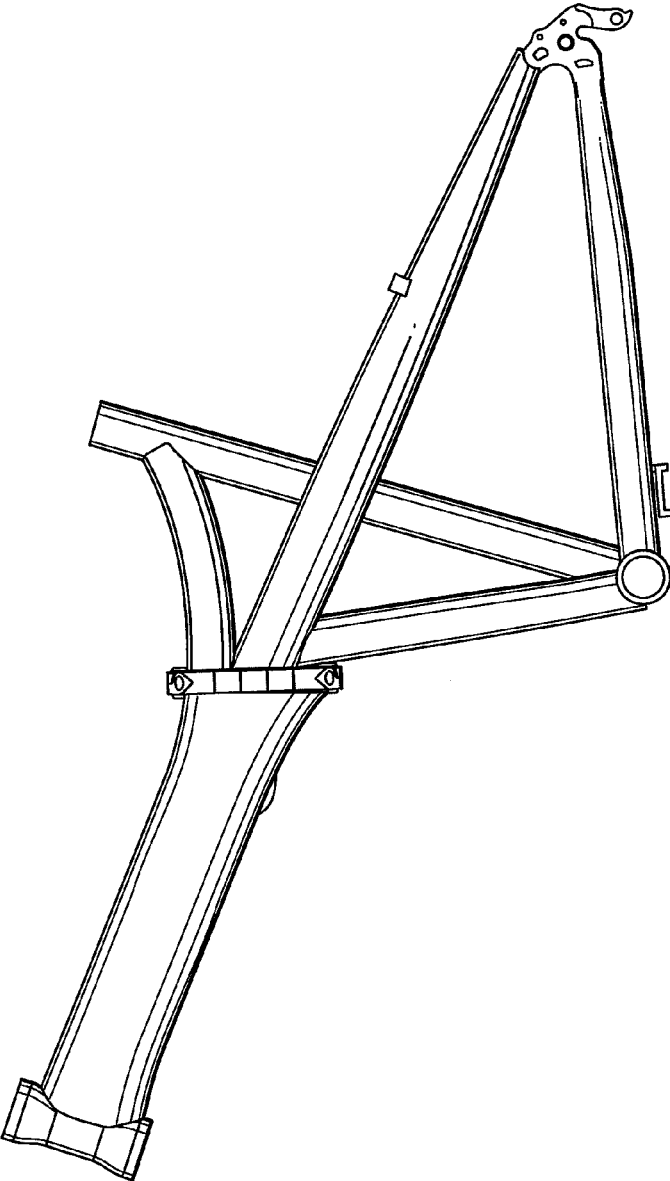

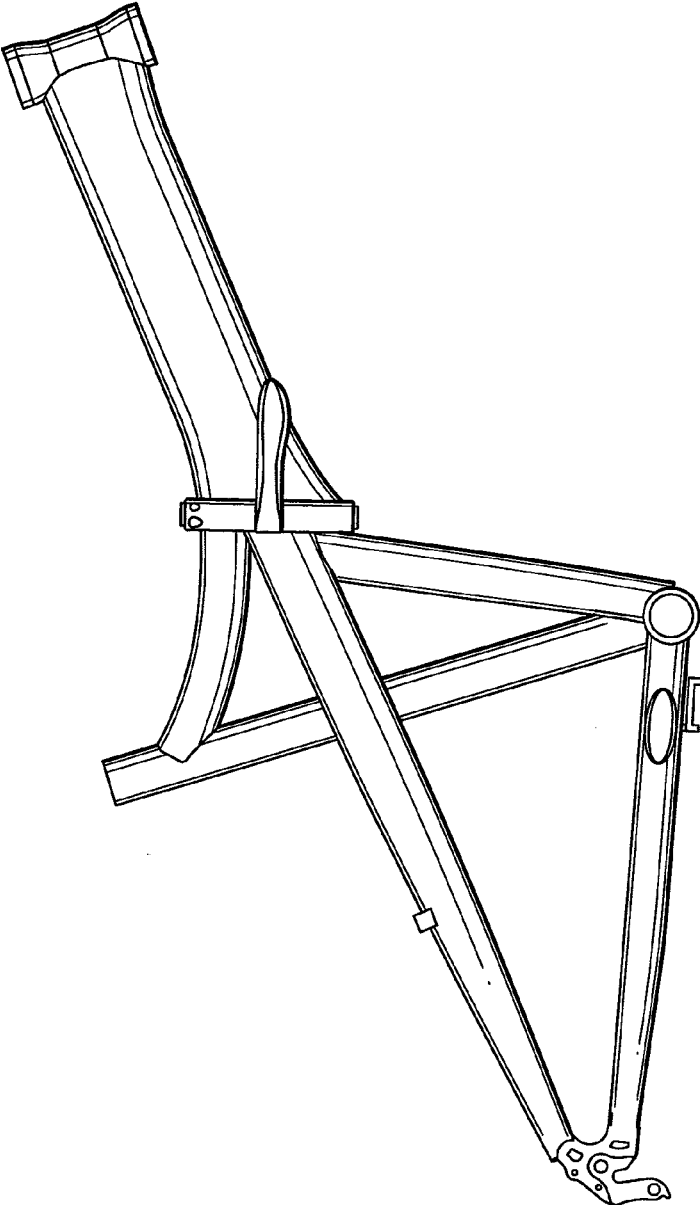

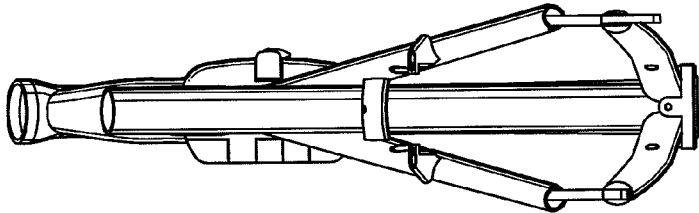

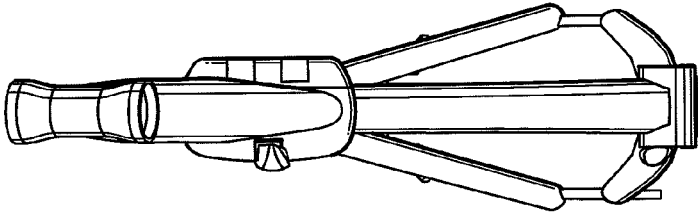

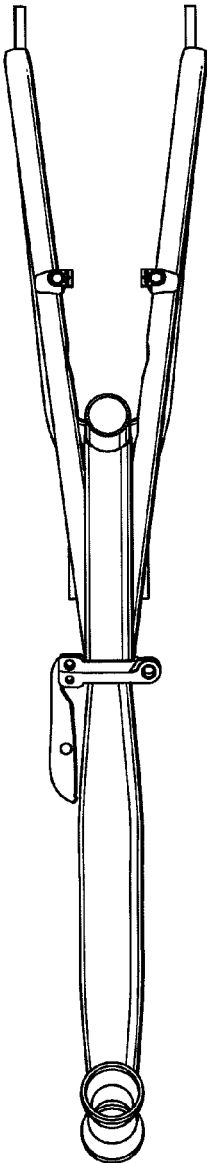

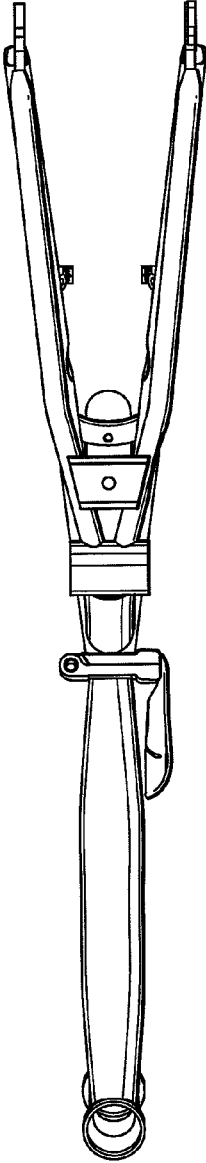

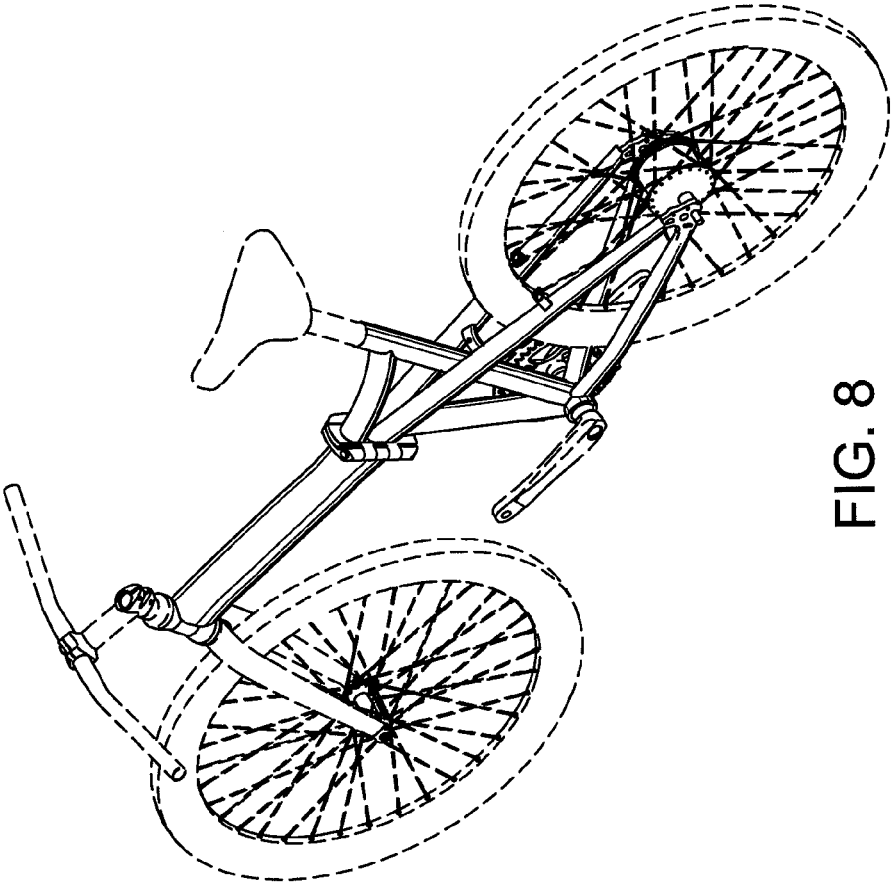
