(57) **CLAIM**
We claim the ornamental design for a bicycle frame, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a bicycle frame according to the invention.

FIG. 2 is a rear elevation view of the bicycle frame shown in FIG. 1.

FIG. 3 is a left side elevation view of the bicycle frame shown in FIG. 1.

FIG. 4 is a top plan view of the bicycle frame shown in FIG. 1; and,

FIG. 5 is a front elevation view bicycle frame shown in FIG. 1.

The right side elevation view of the design is a mirror image of the left side elevation view, so the right side elevation view has been omitted.

The portions of the bicycle frame shown in broken lines illustrate unclaimed structure.

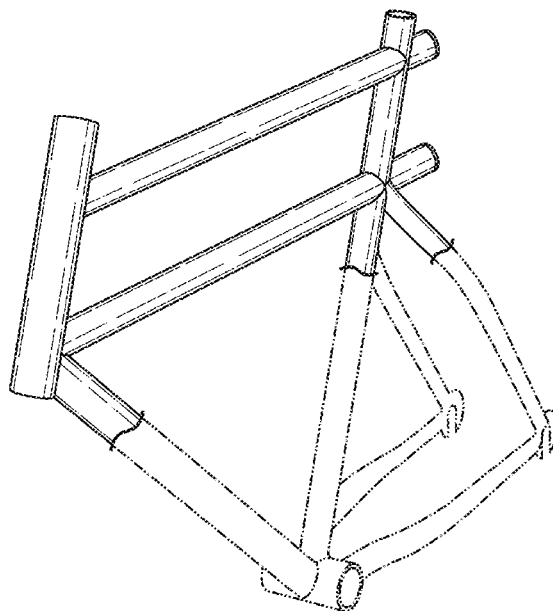

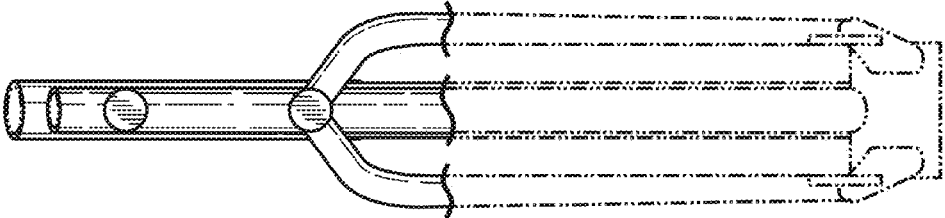
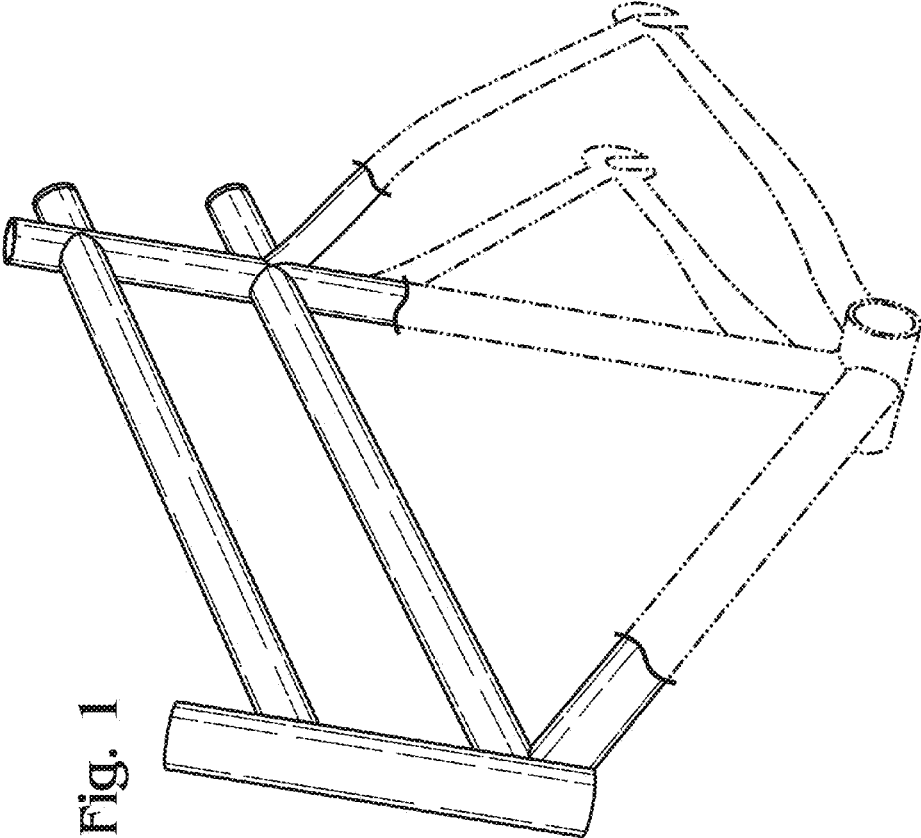

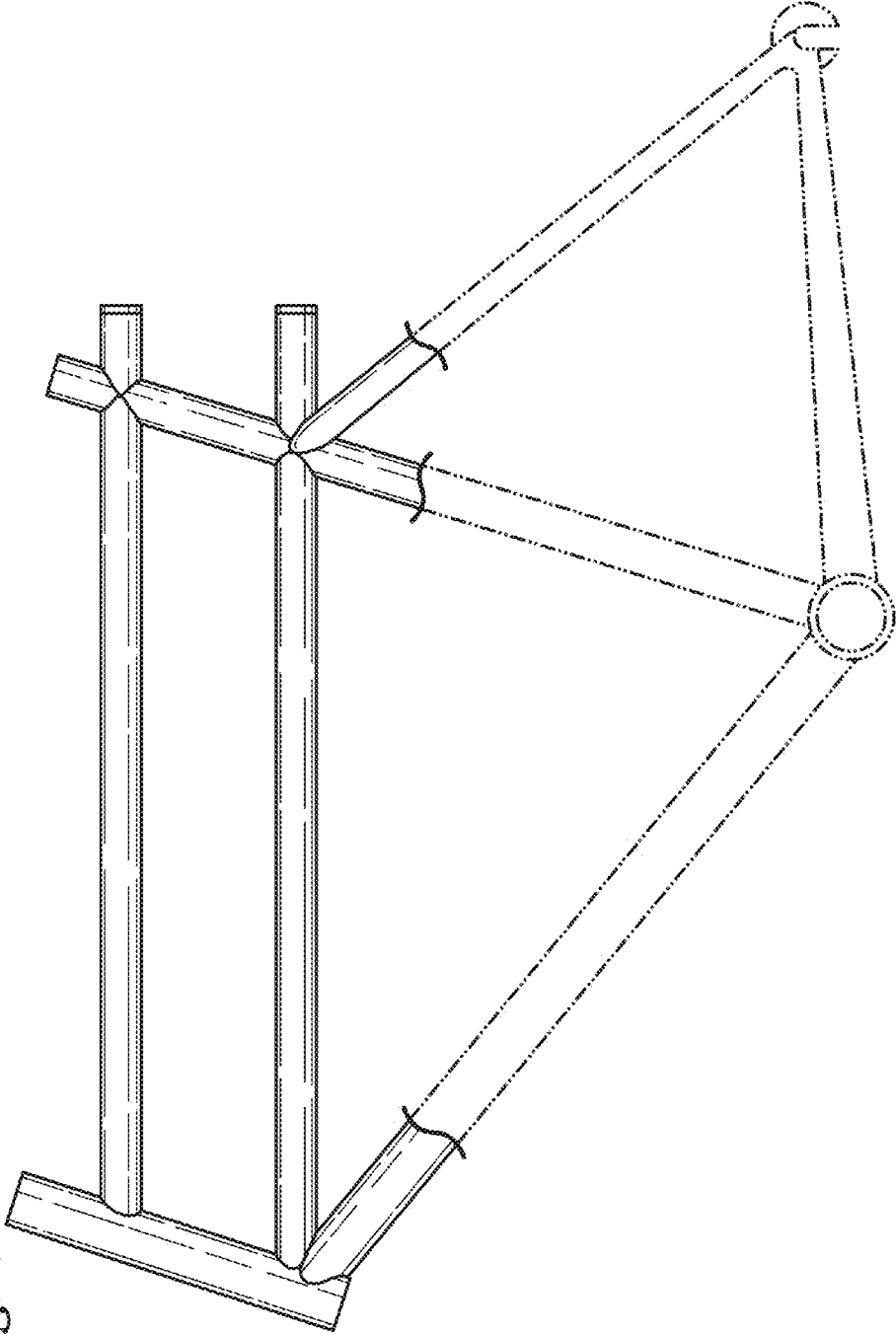

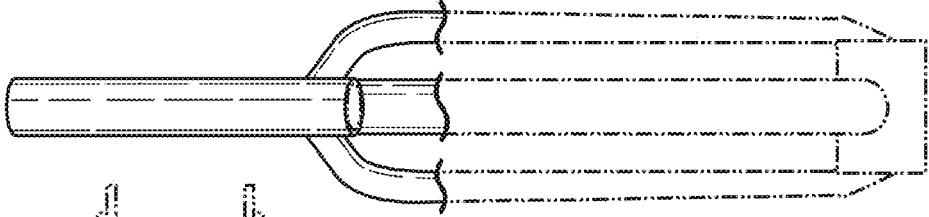
