FIG. 7 is a bottom plan view showing the design for the bicycle drive unit and frame portion of FIG. 1.

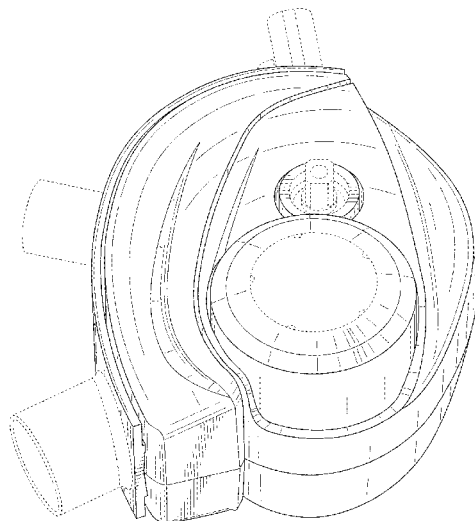
The broken lines shown in the drawings illustrate portions of the bicycle drive unit and frame portion that form no part of the claimed design.

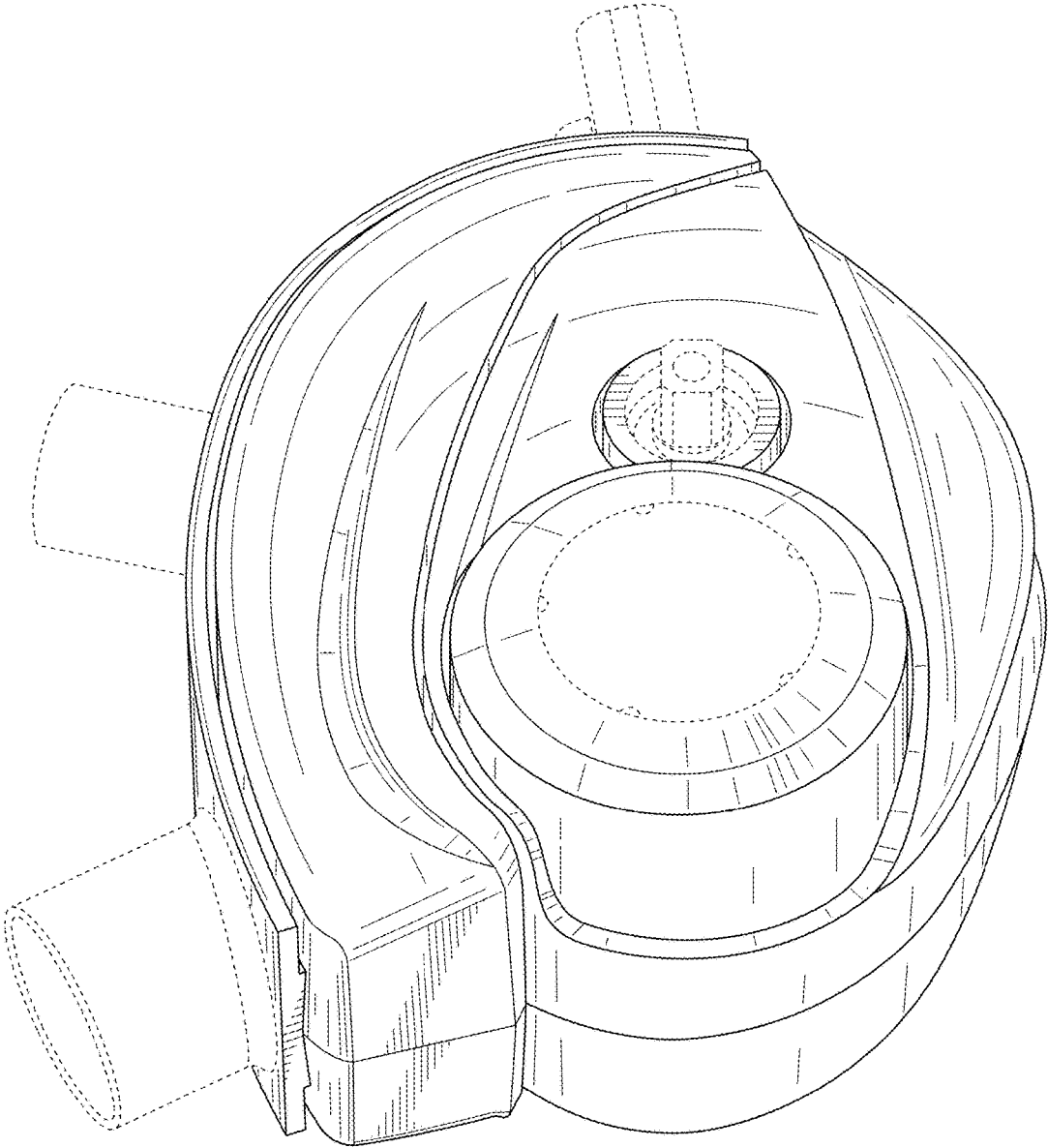

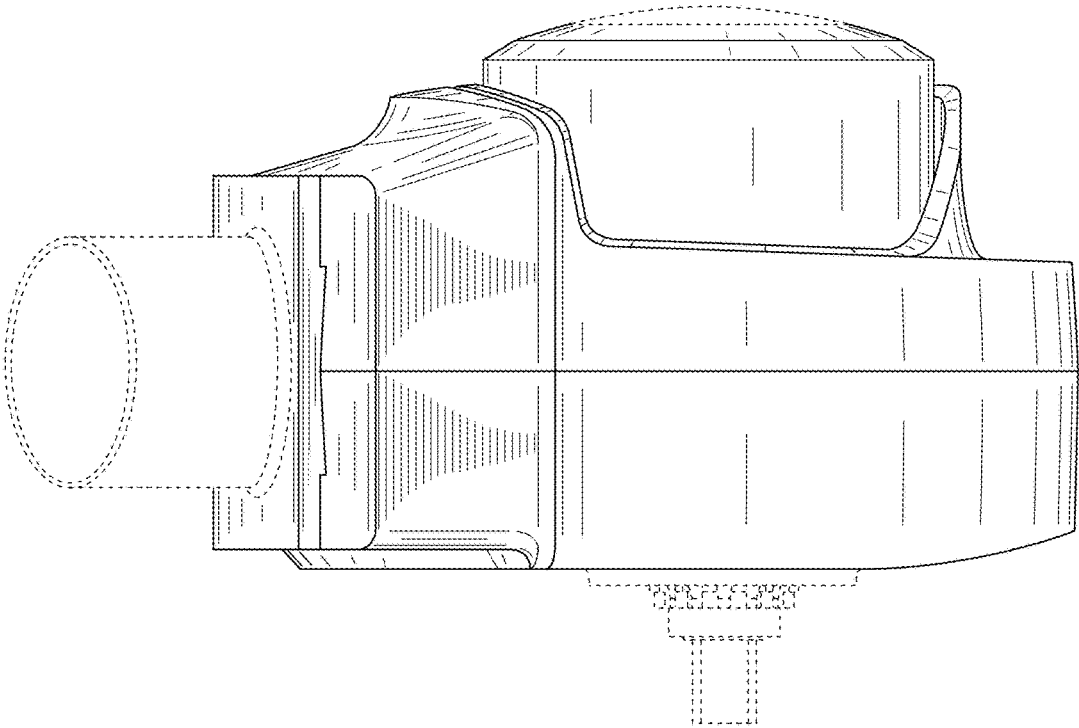

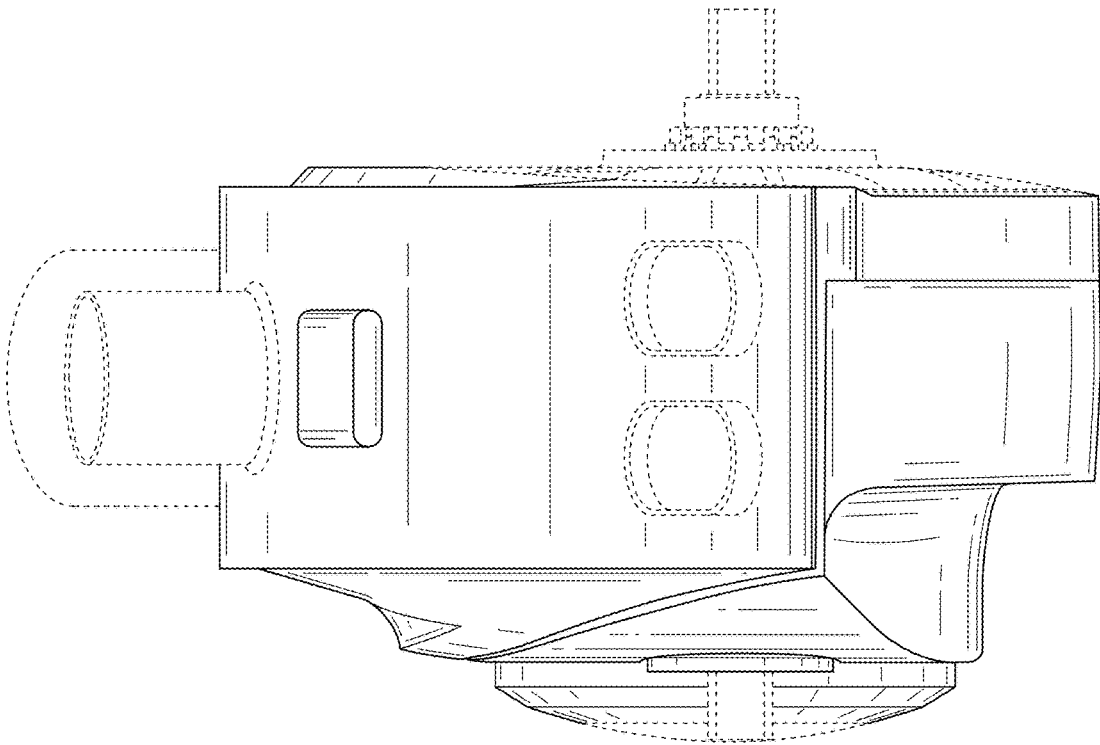

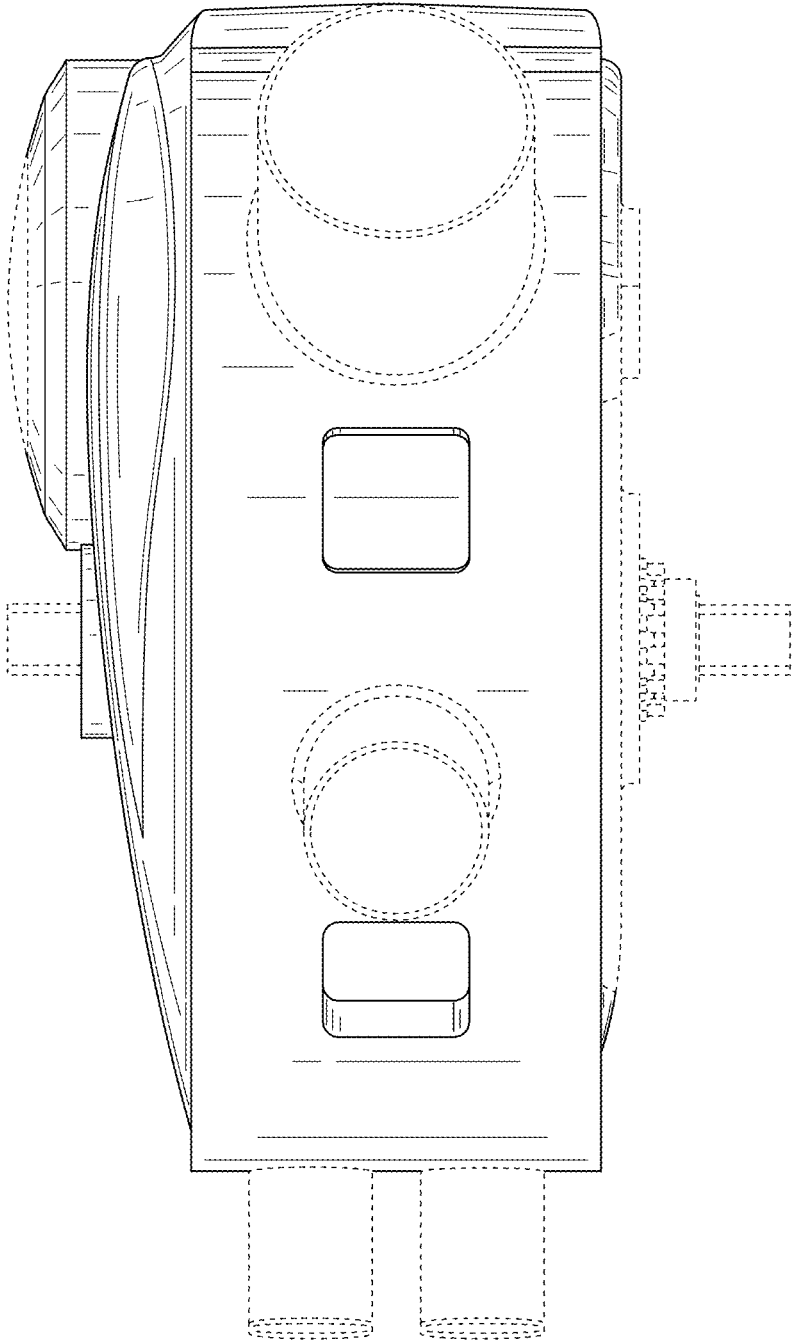

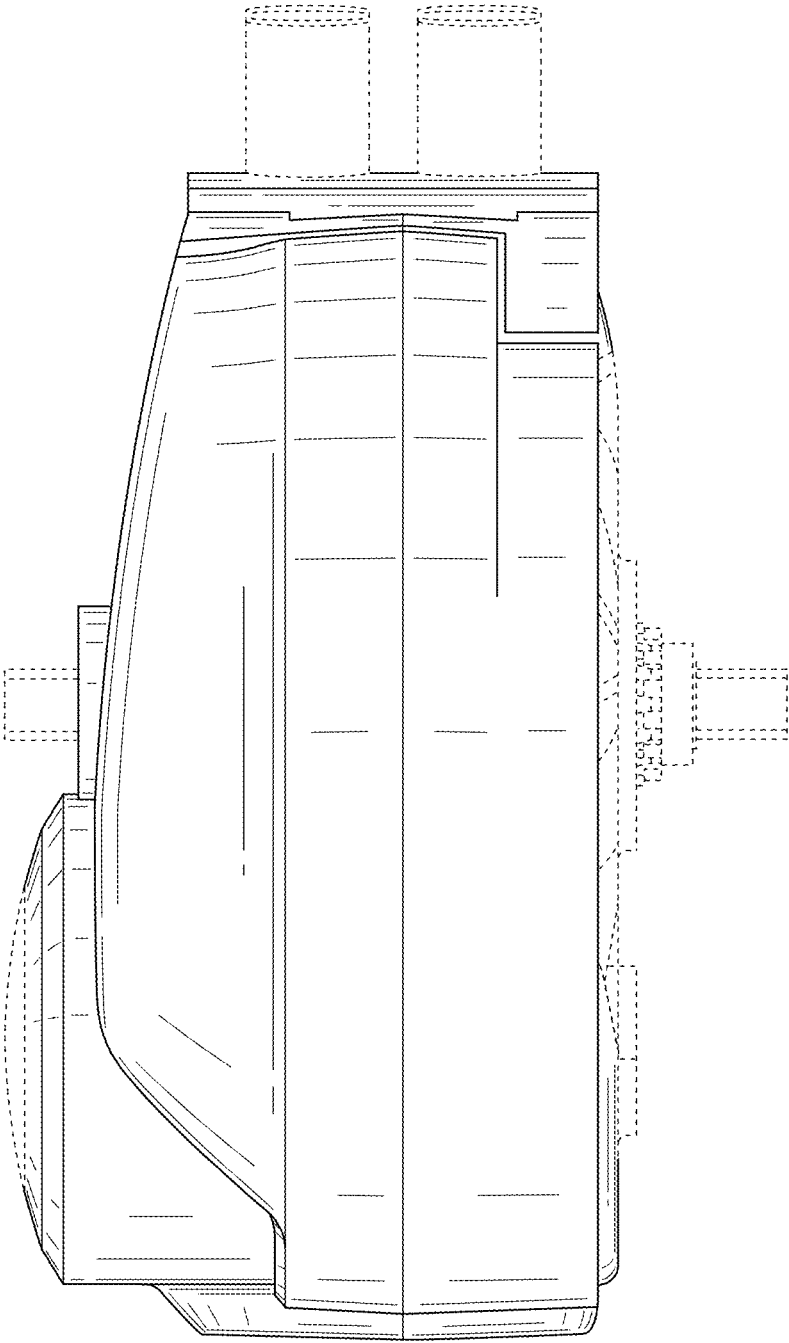

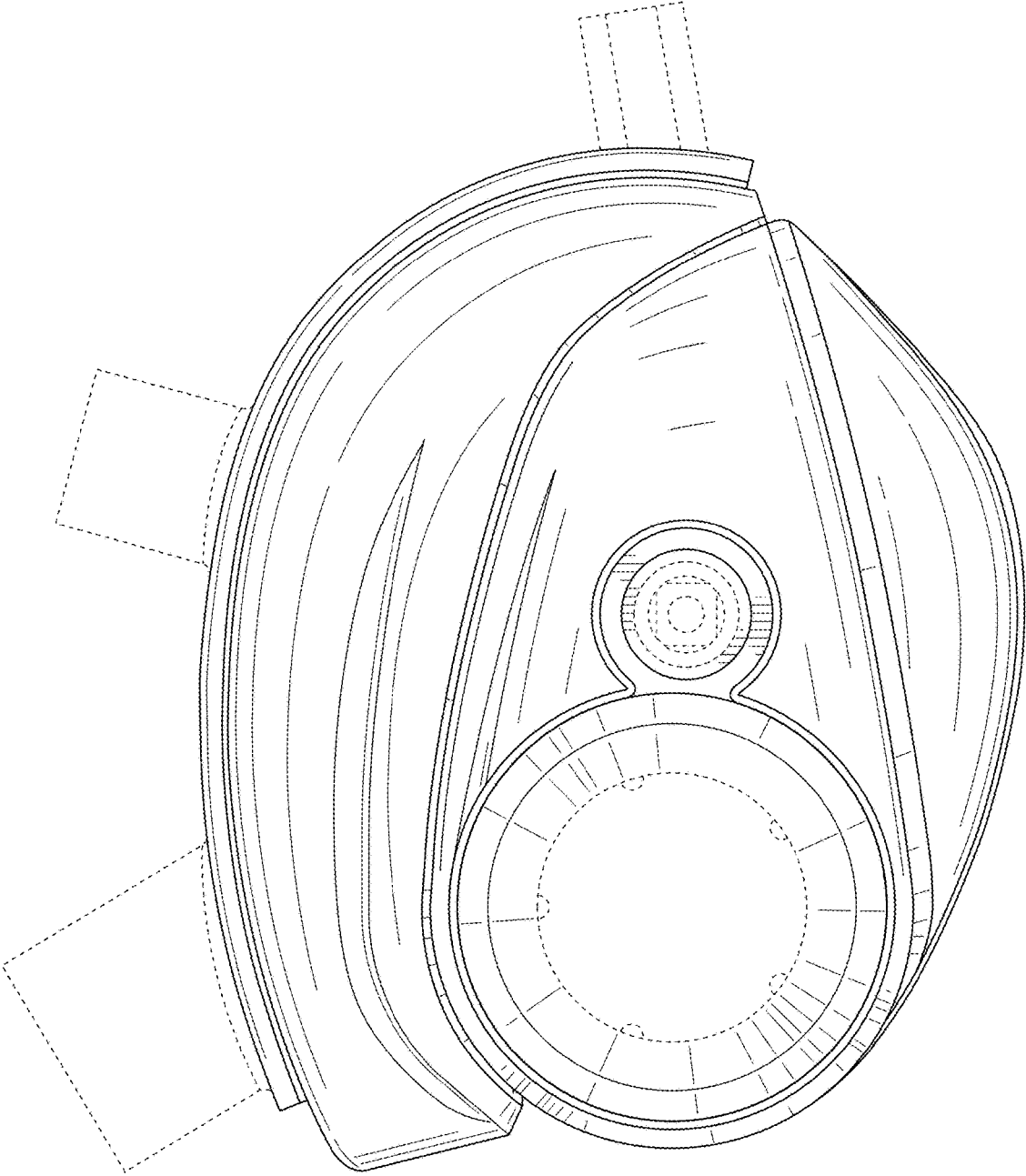

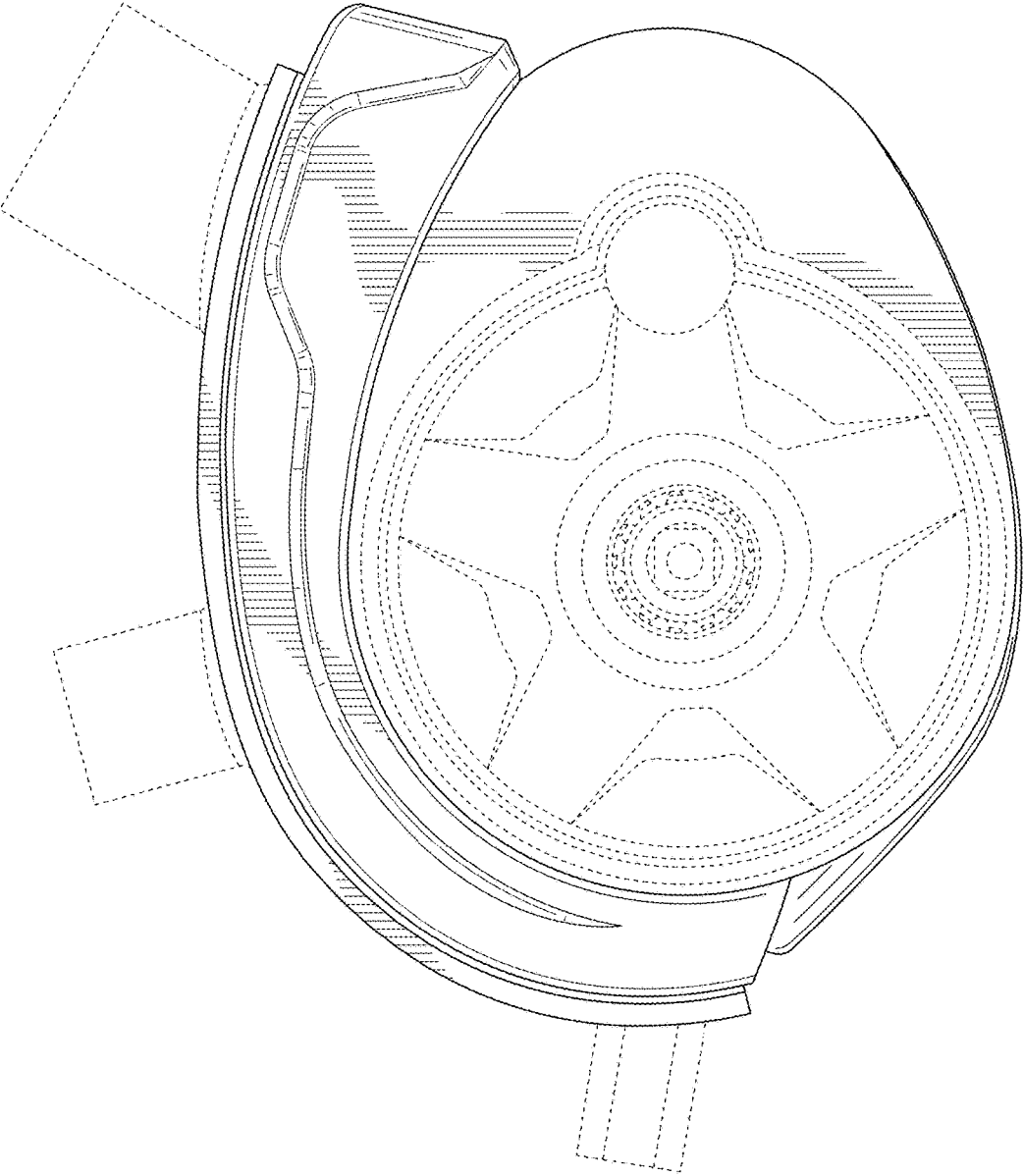
