The ornamental design for “tip of fishing pliers”, as shown and described.

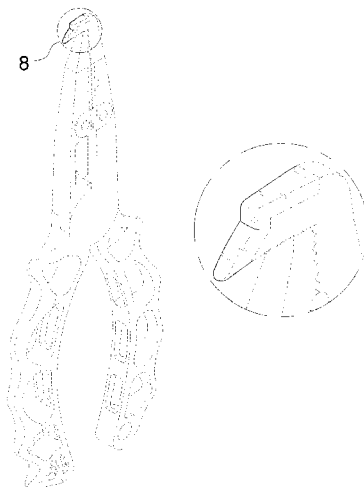
DESCRIPTION

FIG. 1 is a perspective view of tip of fishing pliers showing the claimed design;
FIG. 2 is a front view thereof;
FIG. 3 is a back view thereof;
FIG. 4 is a left side view thereof;
FIG. 5 is a right side view thereof;
FIG. 6 is a top view thereof;
FIG. 7 is a bottom view thereof;
FIG. 8 is an enlarged view along line 8 as shown in FIG. 1;
FIG. 9 is an enlarged view along line 9 as shown in FIG. 2;
FIG. 10 is an enlarged view along line 10 as shown in FIG. 4;
FIG. 11 is an enlarged view along line 11 as shown in FIG. 6; and,
FIG. 12 is a reference view showing the claimed design in use.

The evenly spaced broken lines in the drawings depict environmental subject matter that forms no part of the claimed design. The dot dash dot broken lines depict the boundaries of the claim and form no part thereof.

The claimed design is a part of fishing pliers and configured to be used to open a split ring to hang fishing baits and fishing hooks on the split ring as shown in FIG. 12.

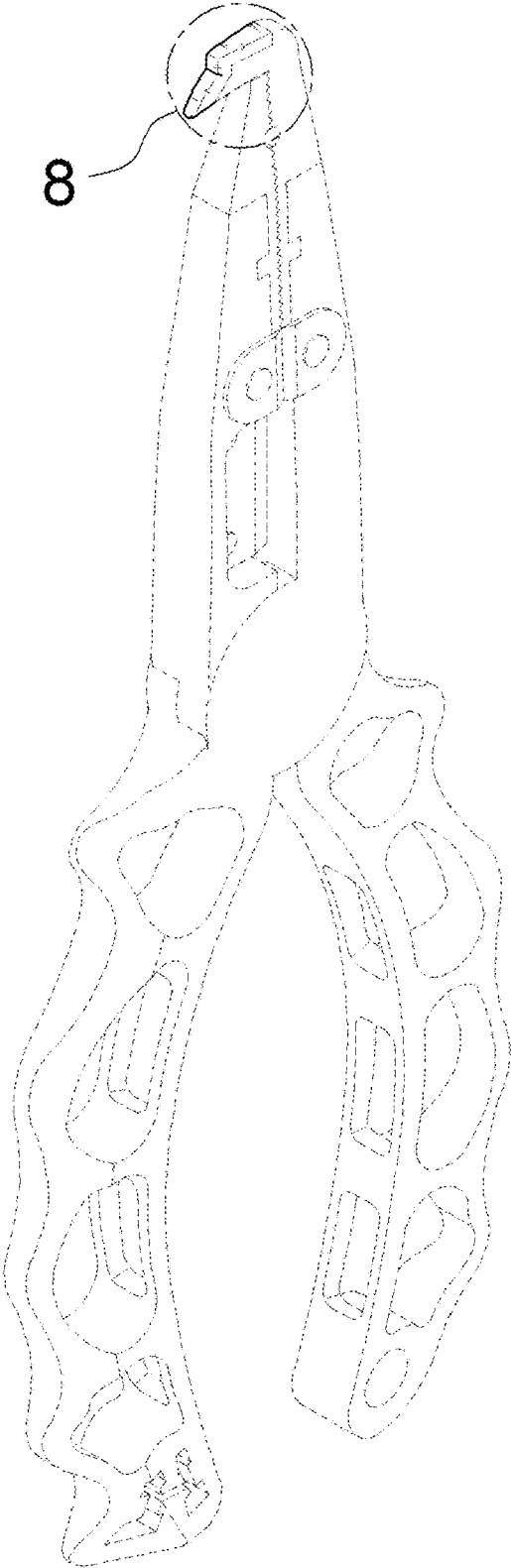

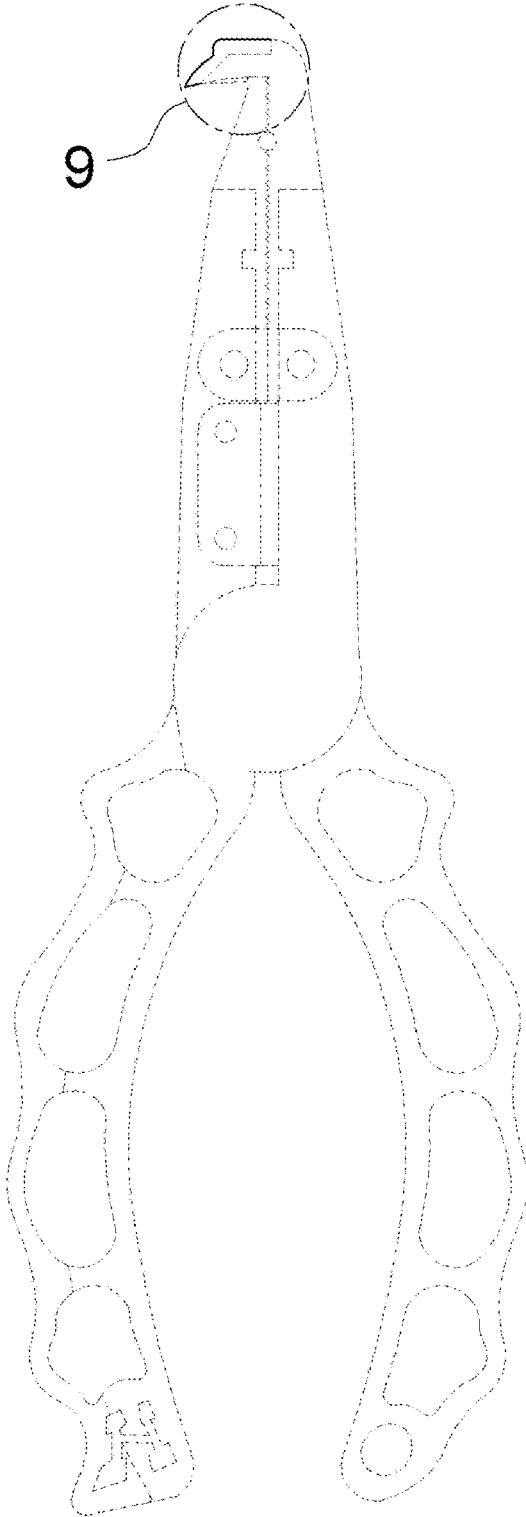

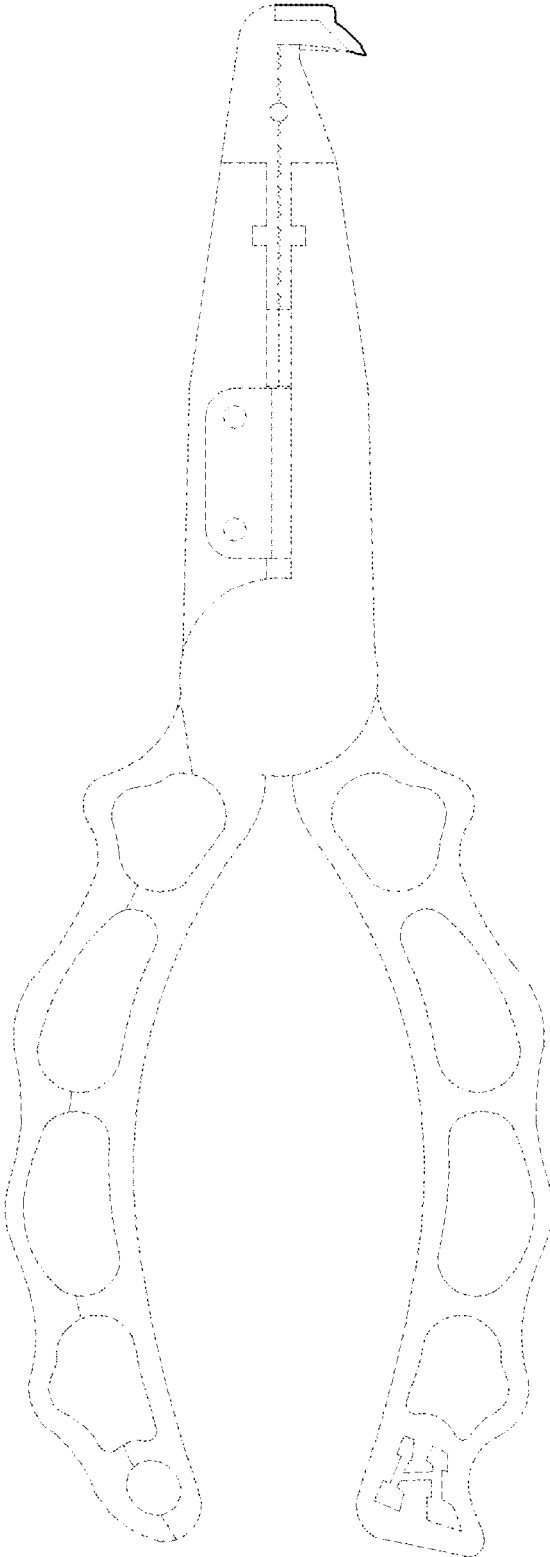

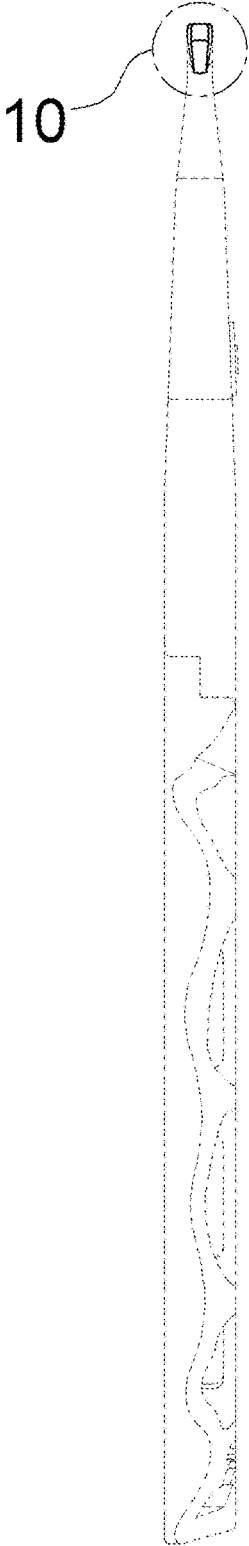

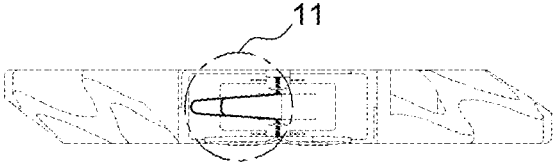

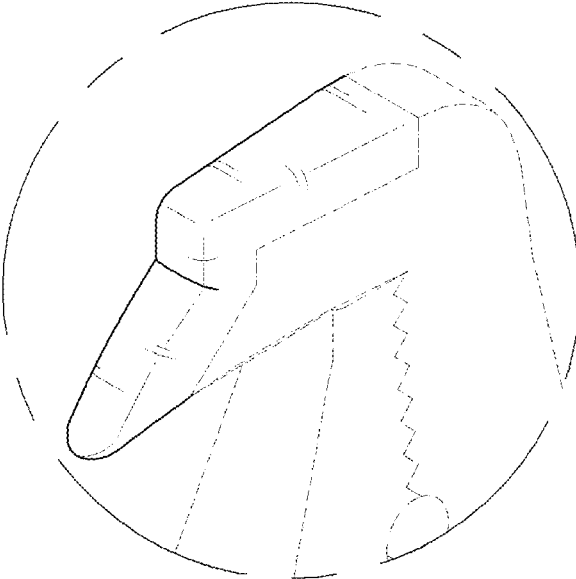

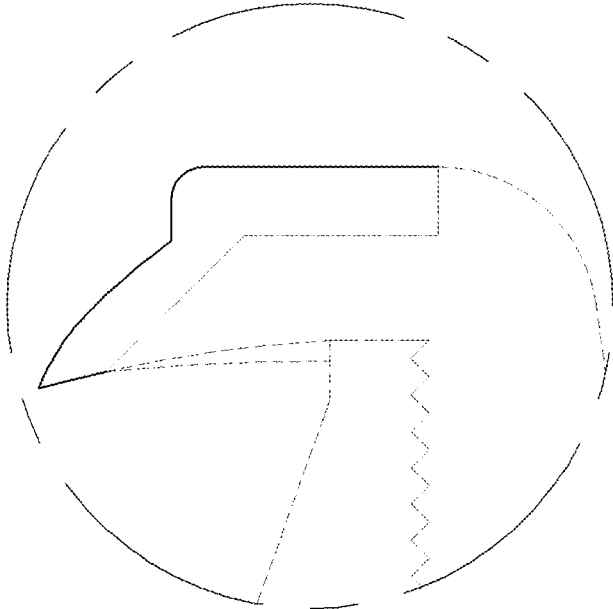

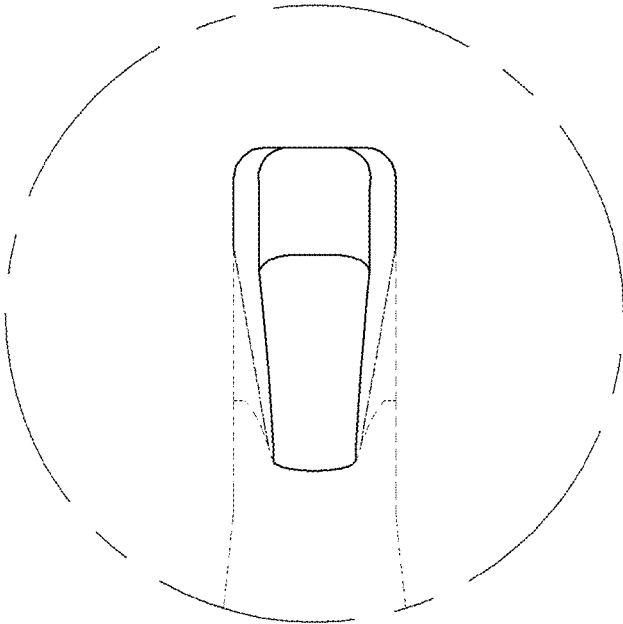

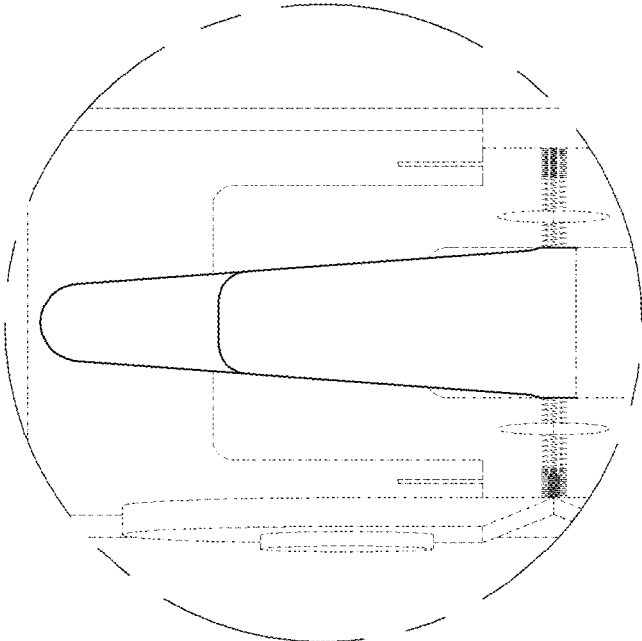
