**DESCRIPTION**

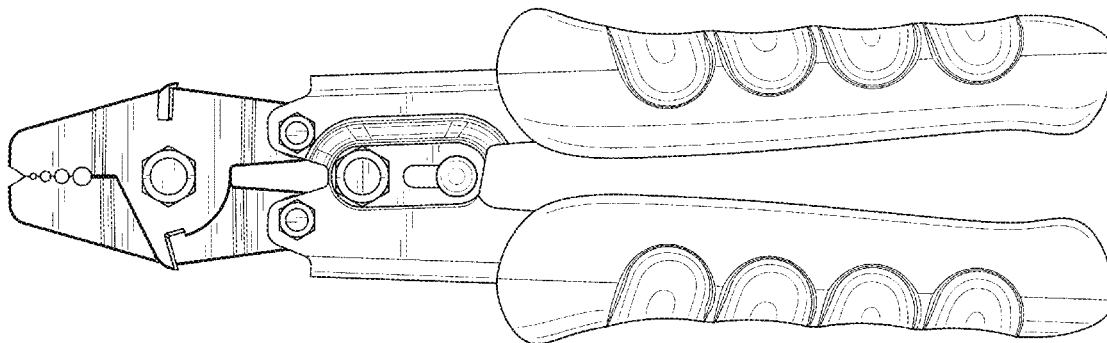
FIG. 1 is a first perspective view of a new and ornamental design for pliers;

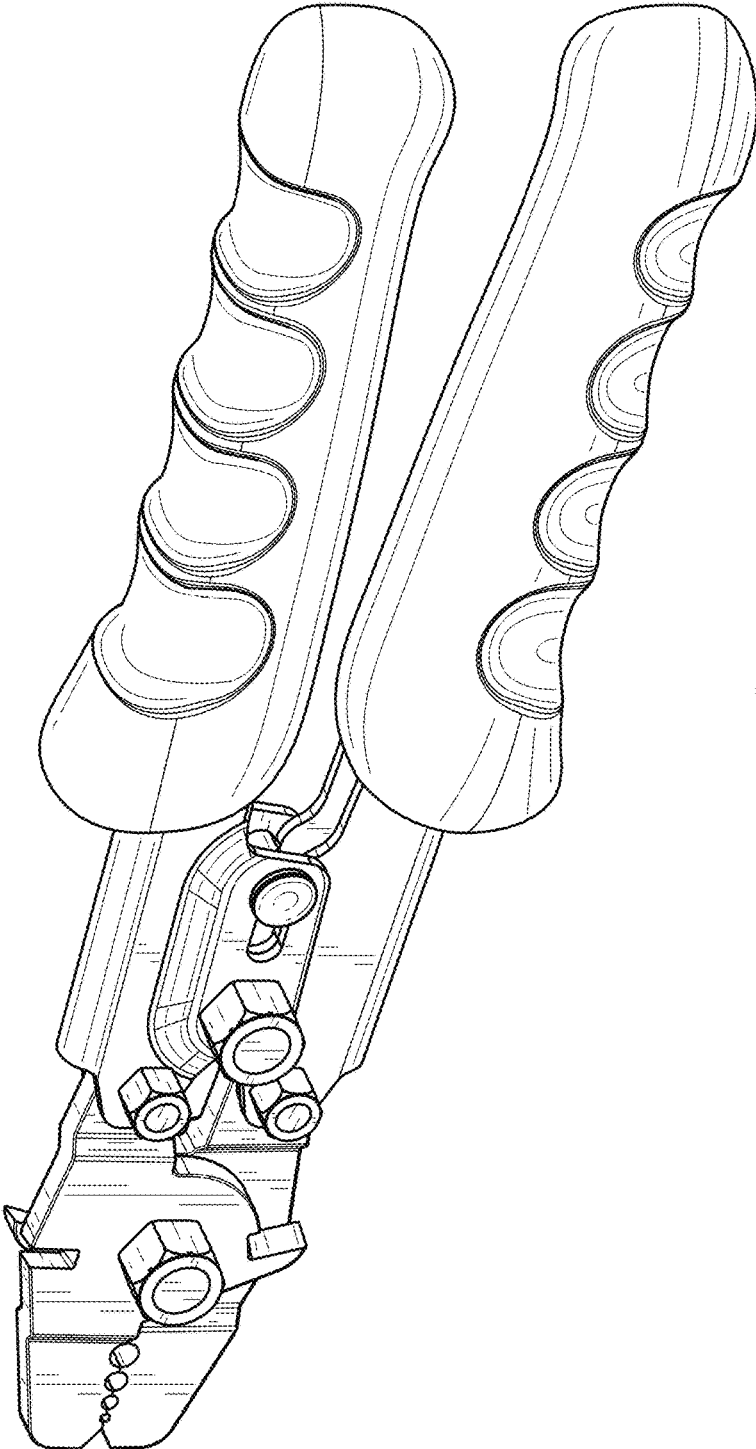

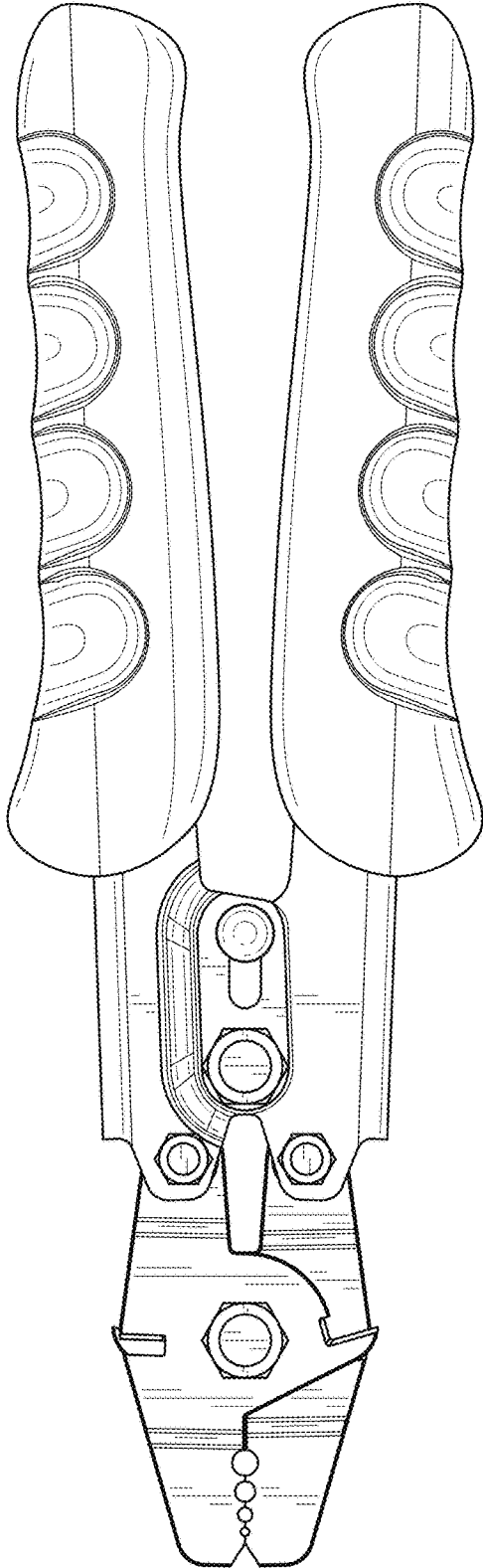

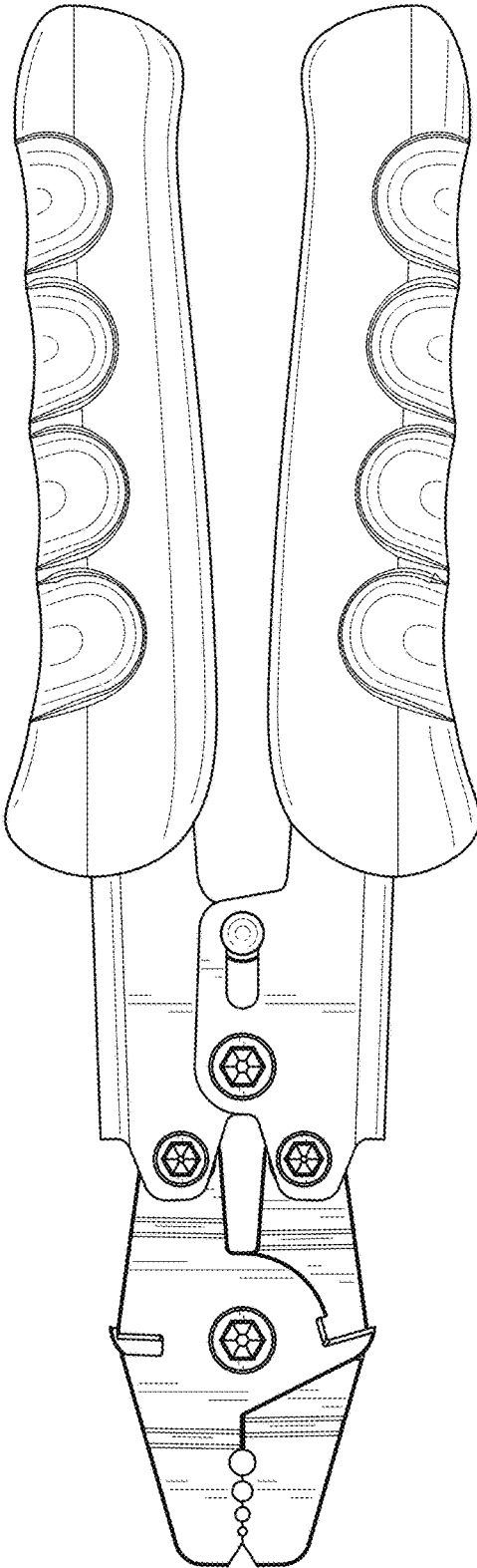

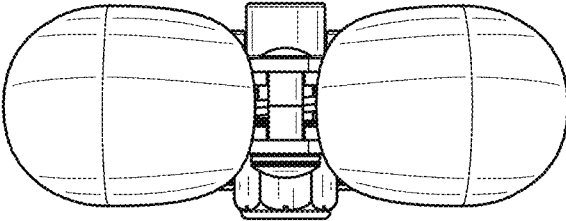

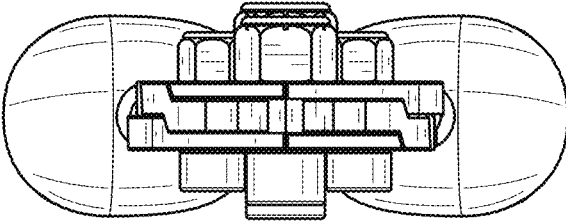

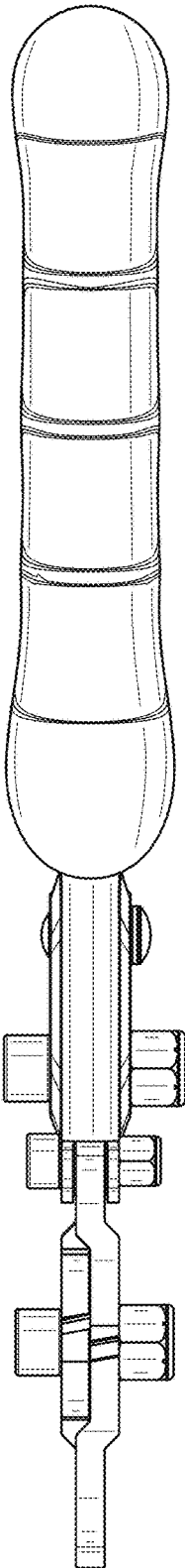

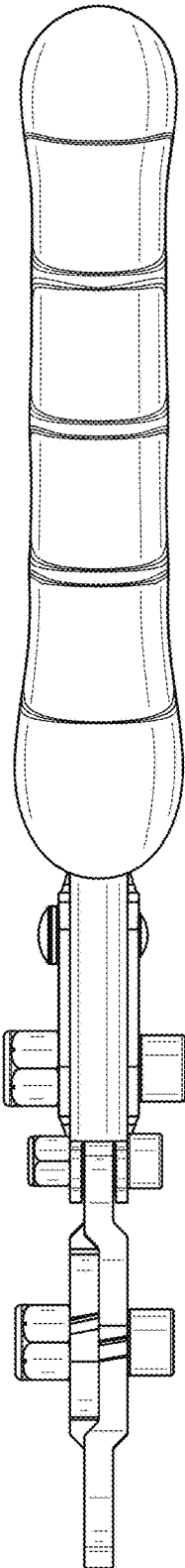
