DESCRIPTION

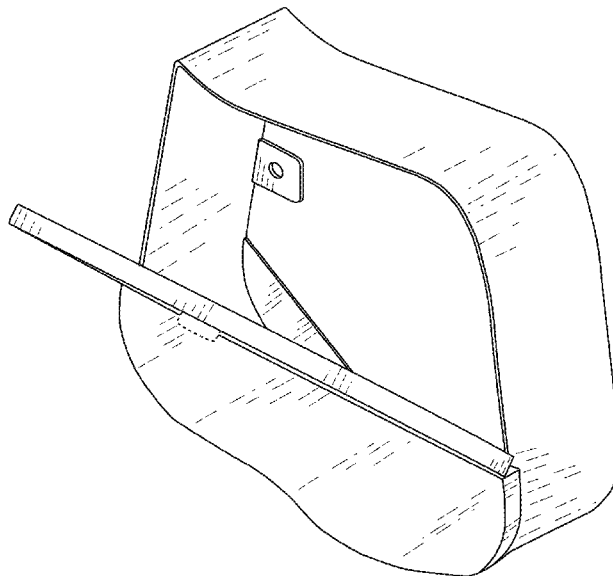
FIG. 1 is a top perspective view of a tool accessory box in an open configuration;

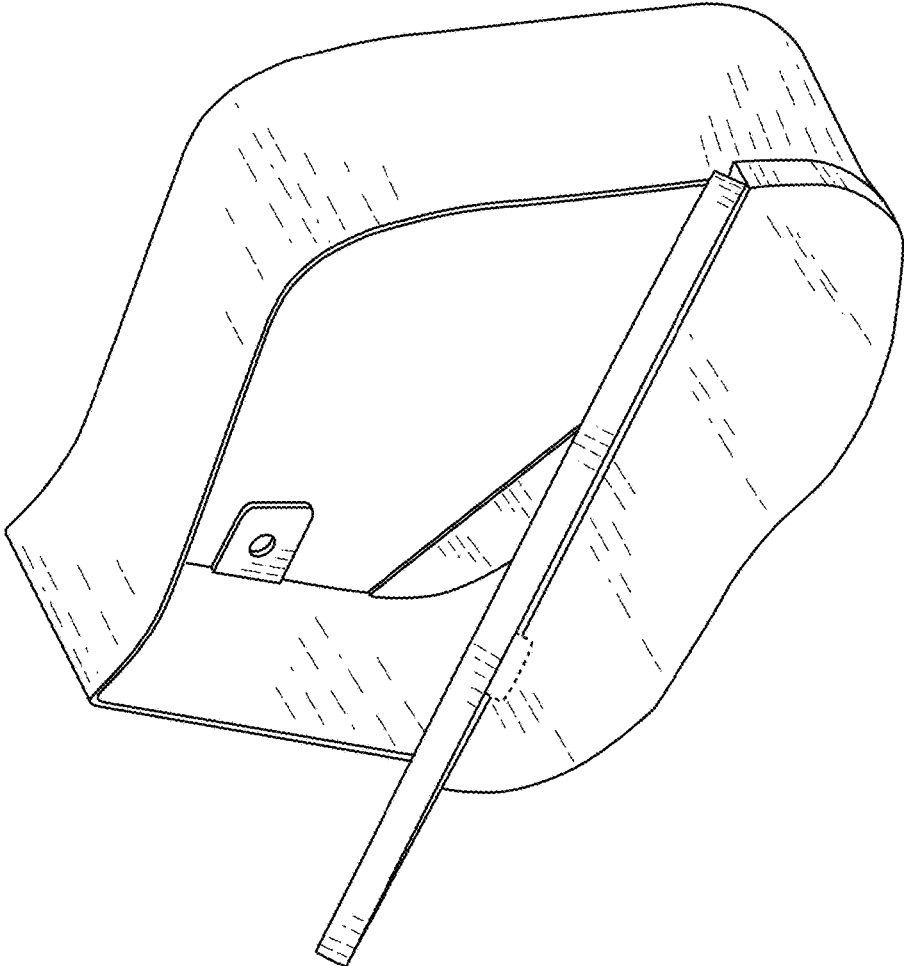

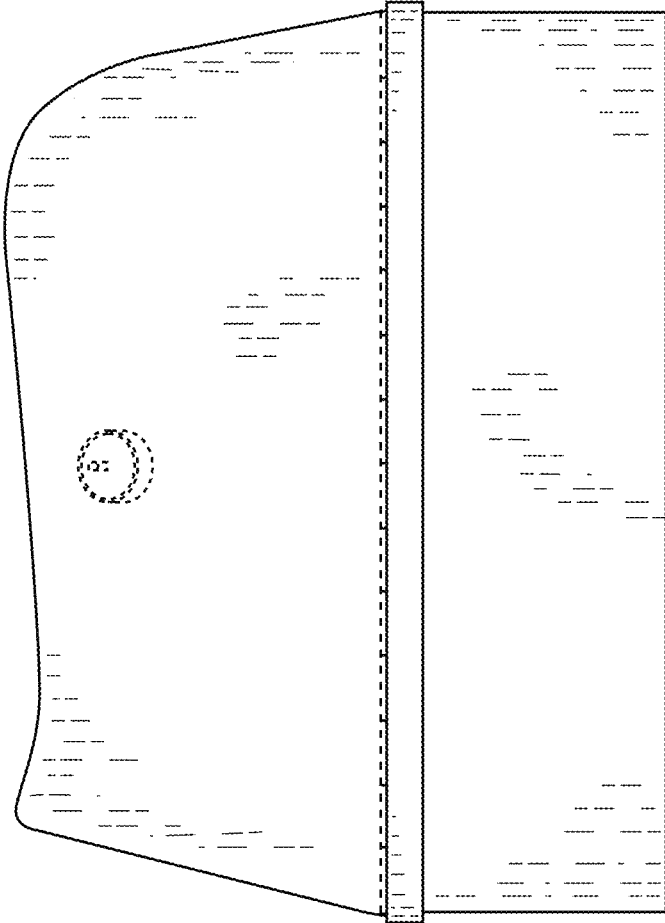

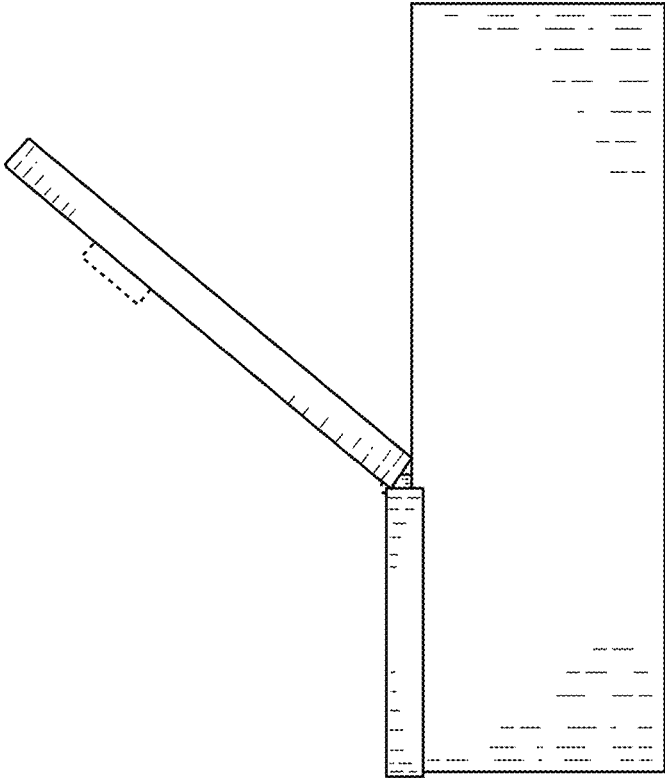

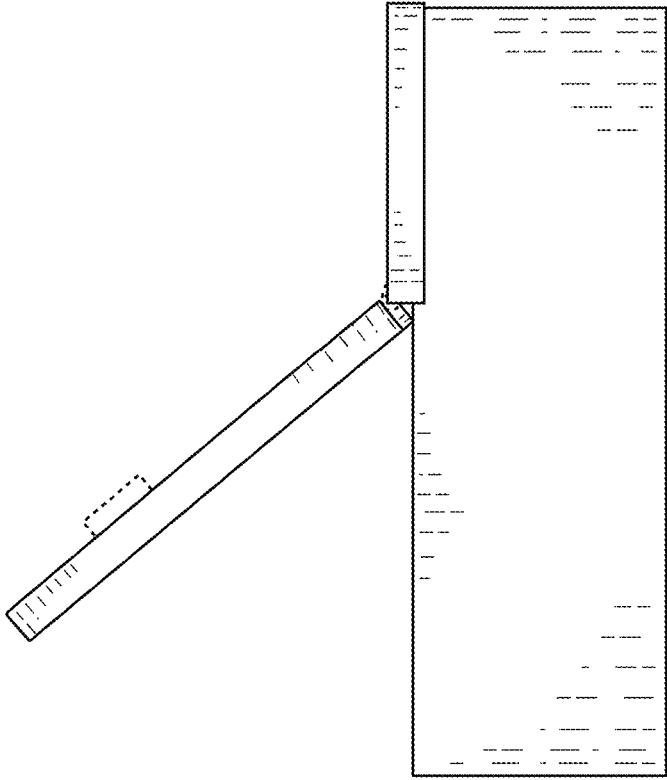

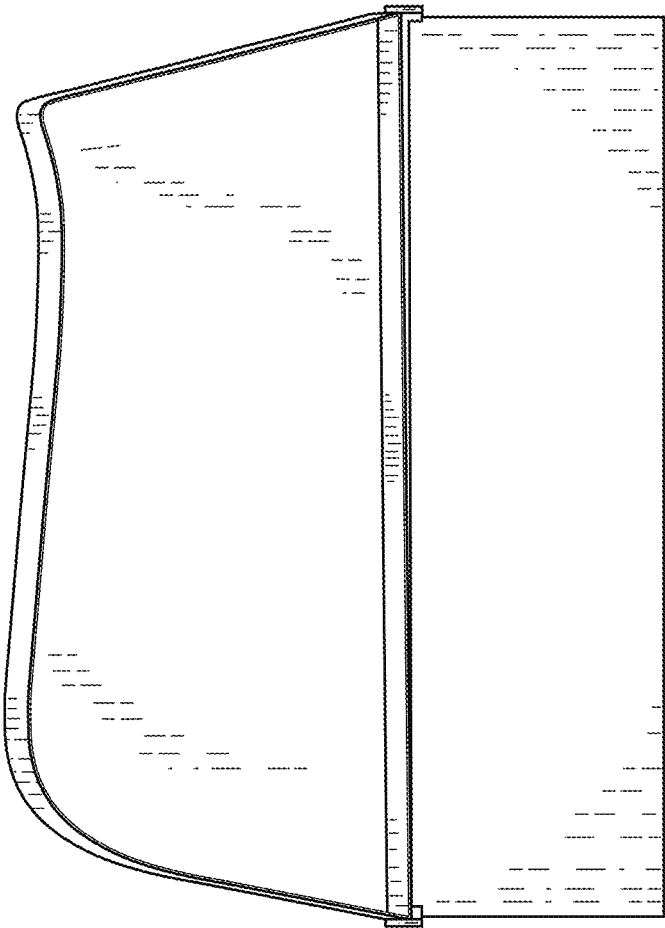

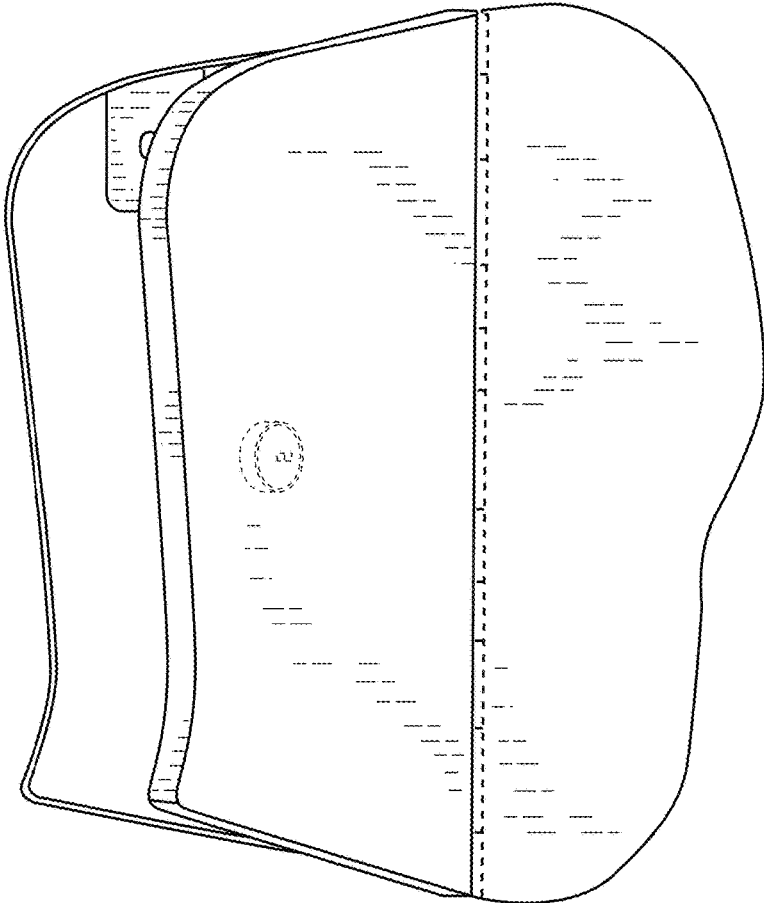

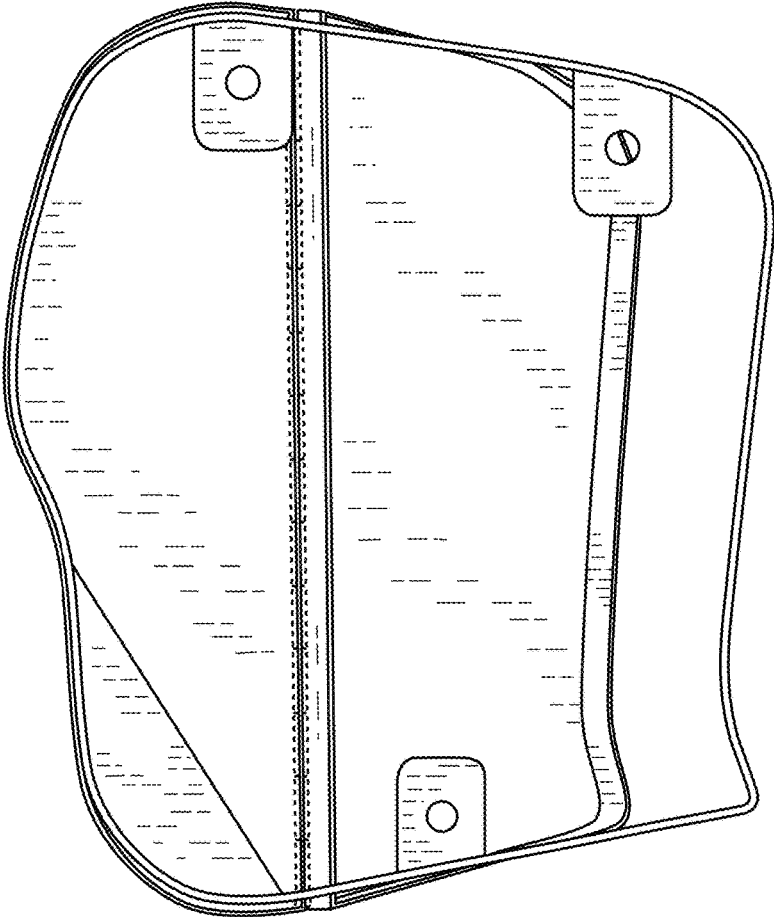

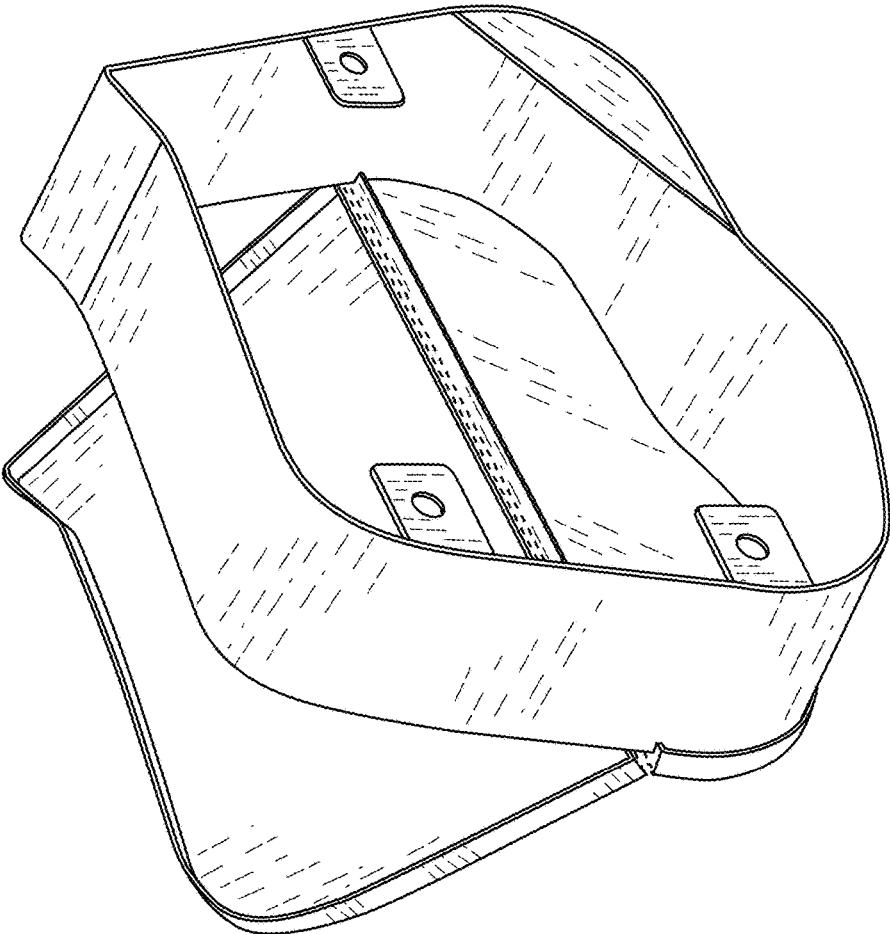

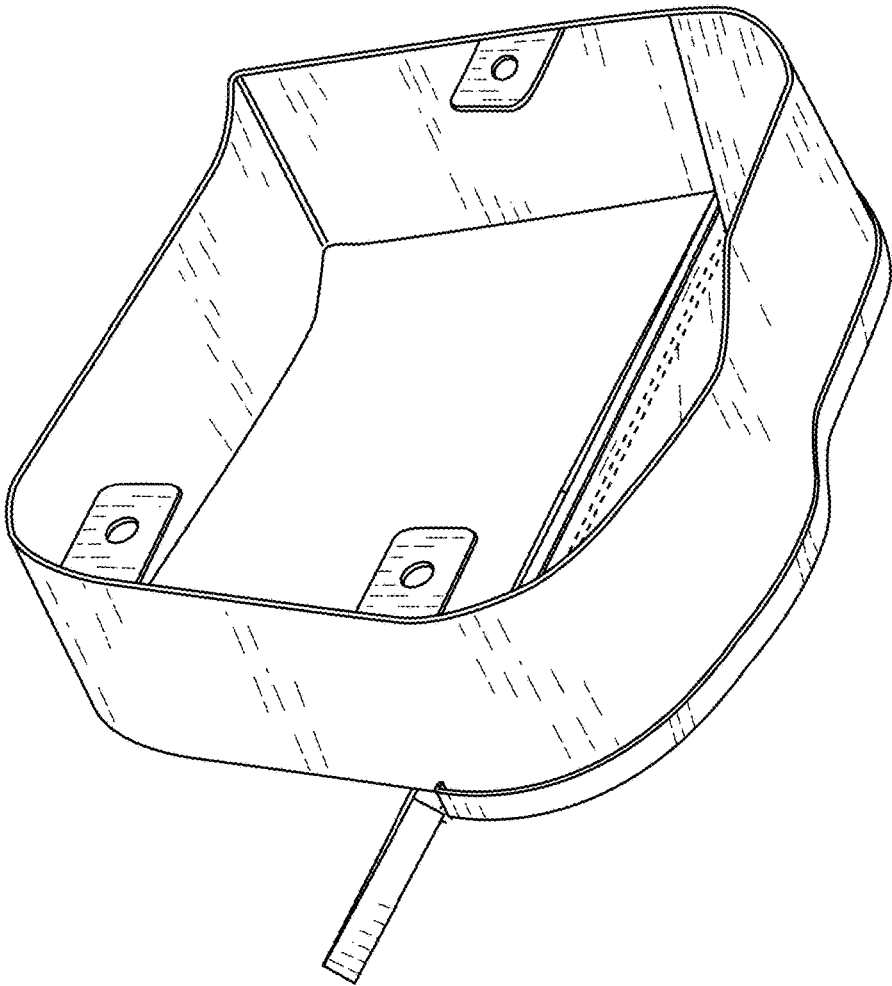

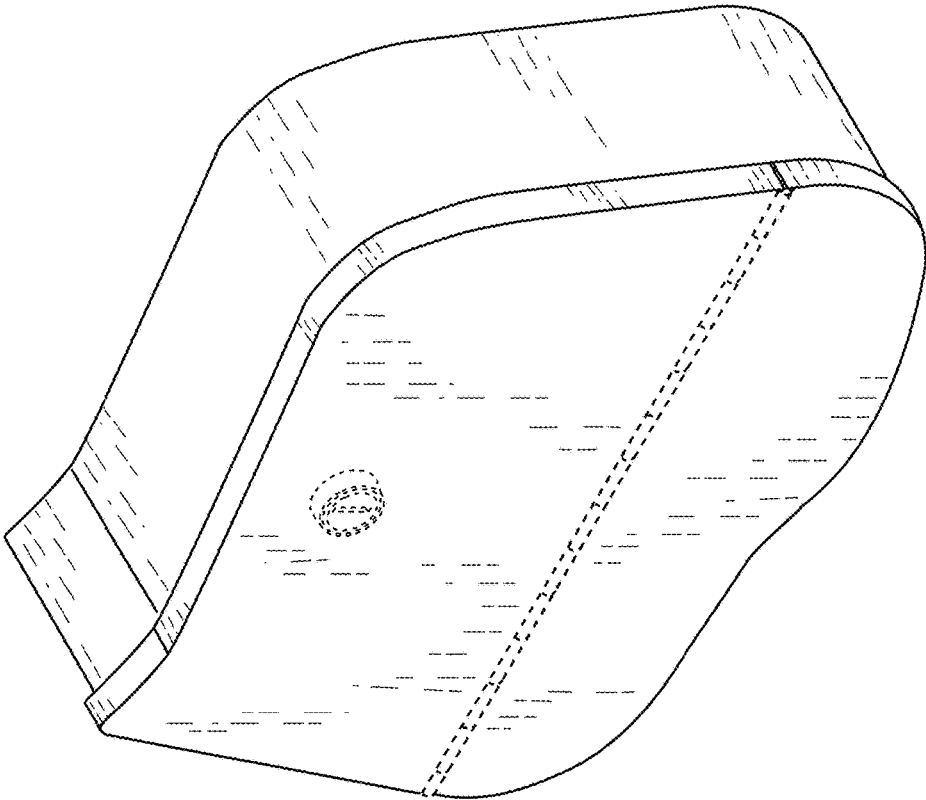

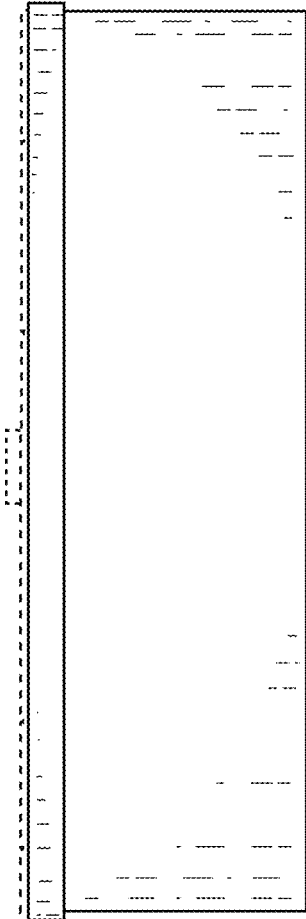

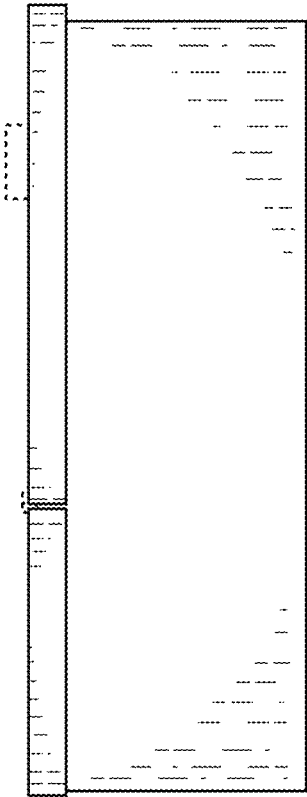

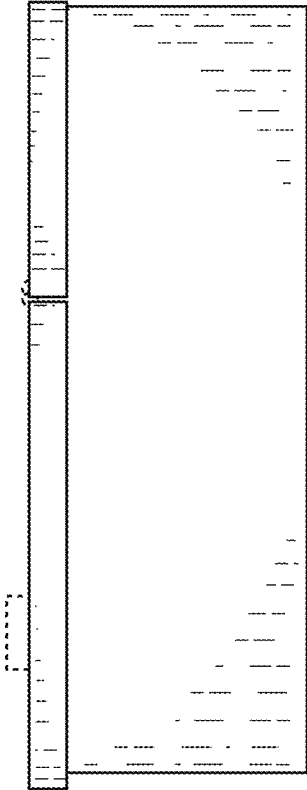

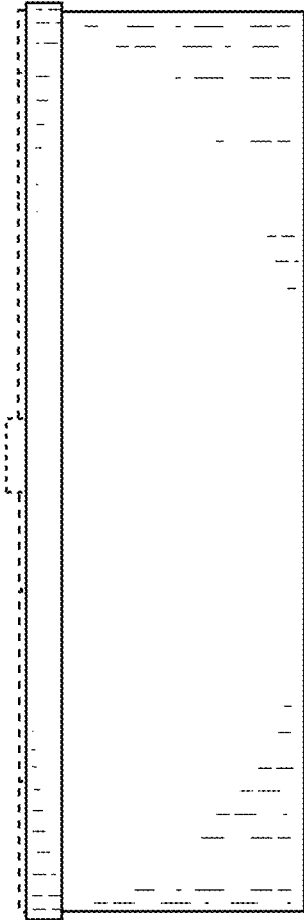

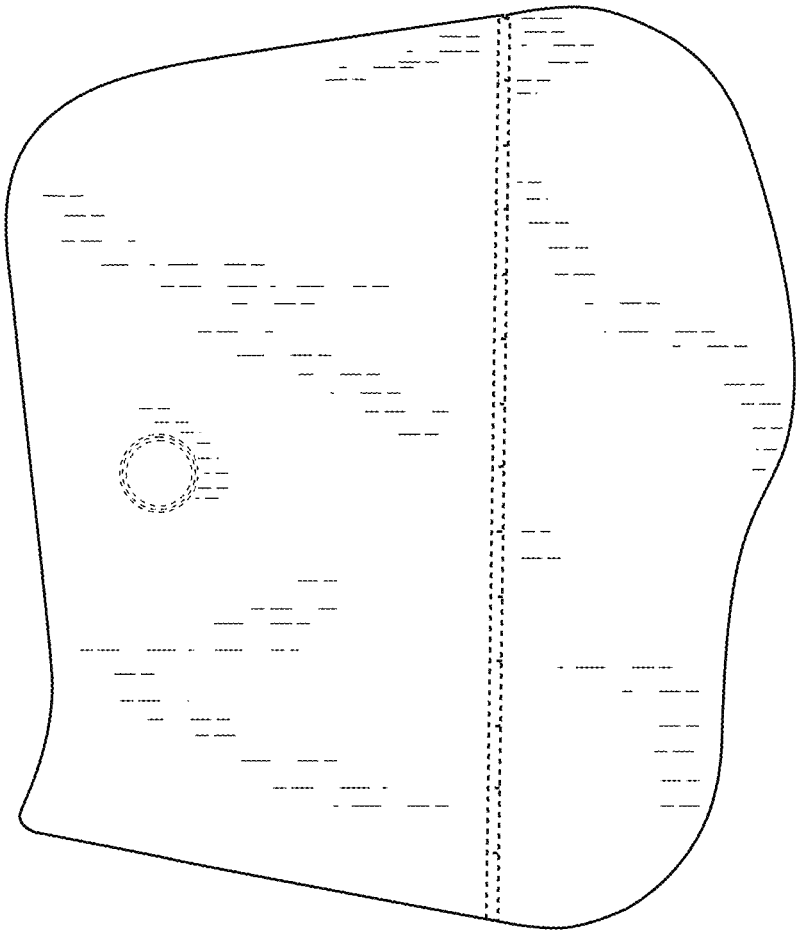

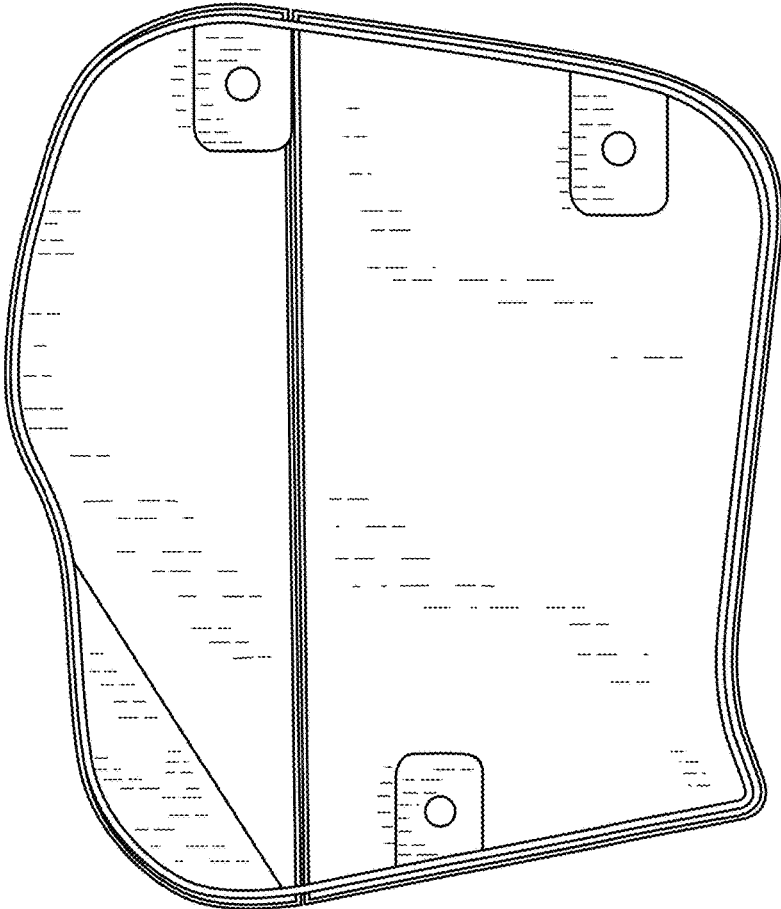
