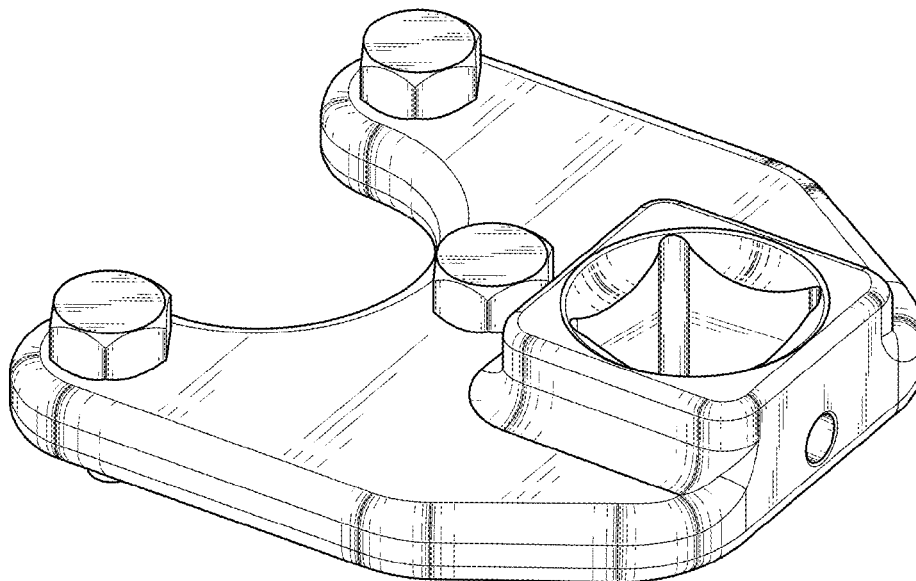
(57) **CLAIM**

The design for pin spanner wrench with gripping teeth, as shown and described.

DESCRIPTION

FIG. 1 is an isometric view of the claimed pin spanner wrench with gripping teeth, embodying the present design; FIG. 2 is a right side view thereof; FIG. 3 is a left side view thereof; FIG. 4 is a rear side view thereof; FIG. 5 is a front side view thereof; FIG. 6 is a top down plan view thereof; and, FIG. 7 is a bottom up plan view thereof. The stippling in the drawings represents texture and forms no part of the claimed design.

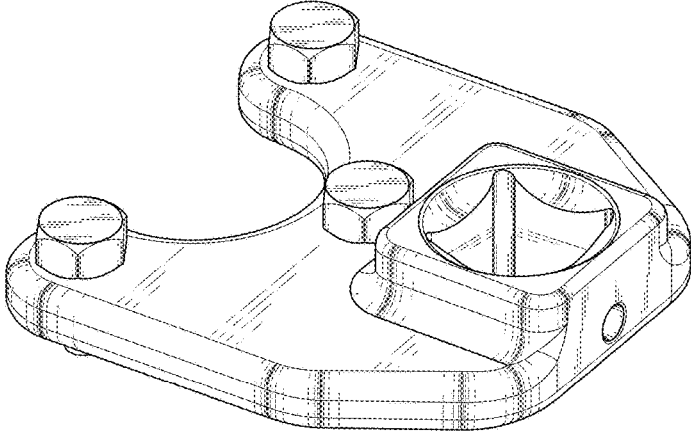

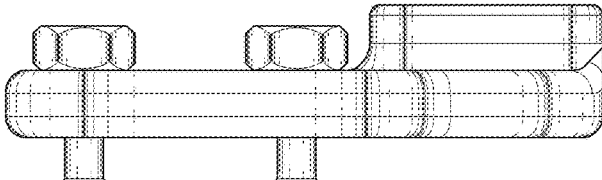

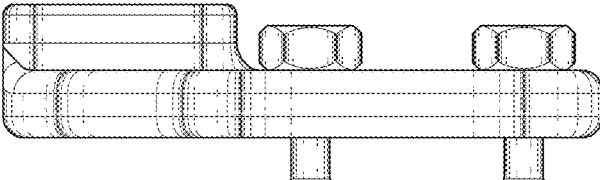

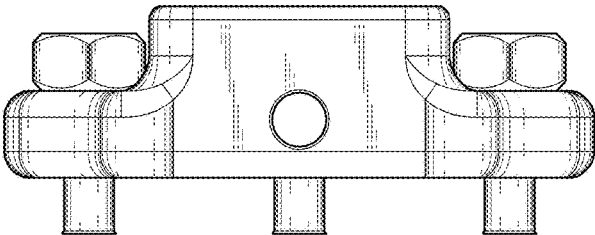

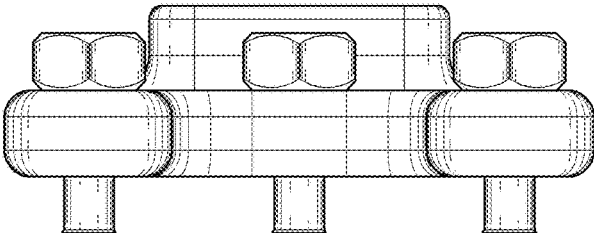

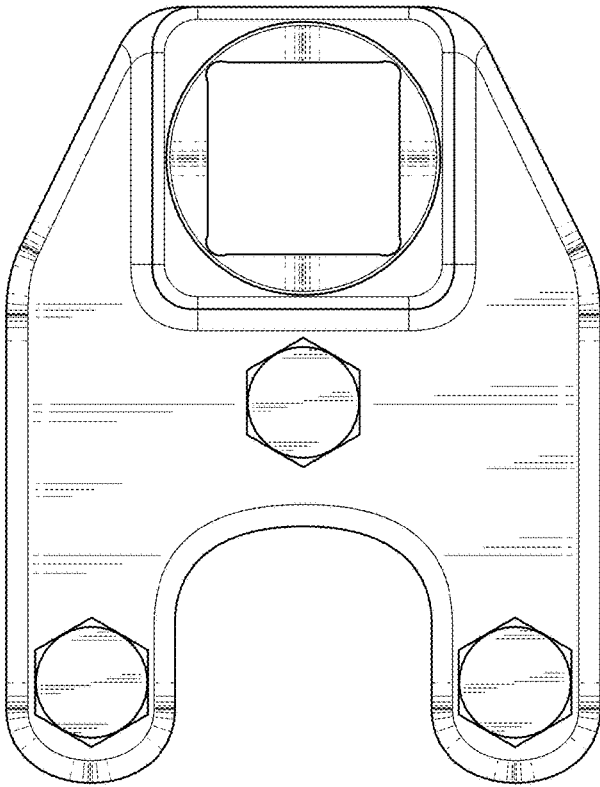

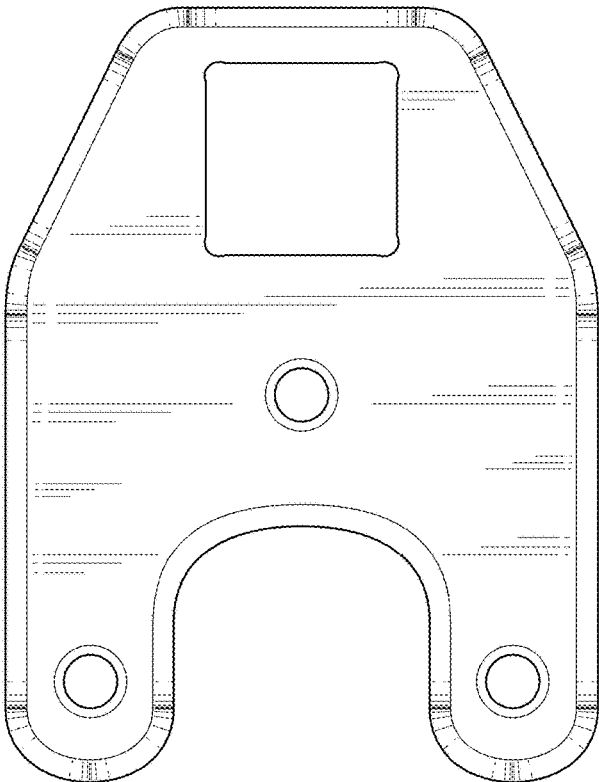
